APPLICATION FOR SIX-MONTH RIGHT-OF-ENTRY FERMIT TO REMOVE DEBRIS FROM ISLANDS IN THE KLAMATH RIVER DELTA, TIDE AND SUBMERGED LANDS OF KLAMATH RIVER, DEL NORTE COUNTY; HUMBOLDT-DEL NORTE COUNTY DEPARTMENT OF PUBLIC HEALTH - W.O. 5601.

An application, dated March 29, 1965, has been received from the Humboldt-Del Norte County Department of Public Health for a six-month right-of-entry permit to remove debris from the islands of the Klamath River Delta seaward of the Douglas Memorial Bridge (see map attached to Exhibit "A").

The debris to be removed was deposited on the islands by the recent flood, and, if left, would constitute a hazard to public health and navigation and in periods of high water could cause additional damage to public end private real property. The removal of the debris will be done by the U.S. Army Corps of Englueers.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE HUMBOLDT-DEL NORTE COUNTY DEPARTMENT OF PUPLIC HEALTH A SIX-MONTH MEDIT-OF-ENTRY PERMIT OVER TIDE AND SUBMERGED LANDS OF THE KLAMATH RIVER DELTA, SEAWARD OF THE DOUGLAS MEMORIAL BRIDGE, FOR THE PURPOSE OF REMOVING DEBRIS FROM ISLANDS WITHIN THAT AREA.
