8. APPLICATION FOR DREDGING PERMIT, SACRAMENTO COUNTY; DEPARTMENT OF WATER RESOURCES - w.O. 5617, P.R.C. 3301.9.

After consideration of Calendar Item 22 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE DEPARTMENT OF WATER RESOURCES A PERMIT FOR THE EXTRACTION OF APPROXIMATELY 2,810 CUBIC YARDS OF MATERIAL FROM THE BED OF THE SACRAMENTO RIVER, WITHOUT THE PAYMENT OF ROYALTY, FOR RECLAMATION AND FLOOD CONTROL IN CONNECTION WITH THE REPAIR OF THE ERODED EAST LEVEE OF THE SACRAMENTO RIVER BETWEEN COURTLAND AND FREEPORT, SACRAMENTO SOUNTY.

APPLICATION FOR DREDGING PERMIT, SACRAMENTO COUNTY; DEPARTMENT OF WATER RESOURCES - W.C. 5617.

An application has been received from the Department of Water Resources to dredge approximately 2,810 cubic yards of material from the bed of the Sacramento River between Courtland and Freeport at the following specific locations on the river and to deposit the dredged material on the adjacent eroded levees:

The original plan was to dredge the material during the week of April 12; however, high water prevented the work from being undertaken at that time, and it is now proposed that this emergency work be done during the month of May 1965. Immediate repairs are necessary on portions of the east levee of the Sacramento River, immediately south of the City of Sacramento, that suffered damage during the recent period of high water. The Department of Water Lesources will secure project approval from the Corps of Engineers and from the Department of Fish and Game. The project will be managed by the Reclamation Board.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE DEPARTMENT OF WATER RESOURCES A PERMIT FOR THE EXTRACTION OF APPROXIMATELY 2,810 CUBIC YARDS OF MATERIAL FROM THE BED OF THE SACRAMENTO RIVER, WITHOUT THE PAYMENT OF ROYALTY, FOR RECLAMATION AND FLOOD CONTROL IN COMMECTION WITH THE REPAIR OF THE EROLED EAST LEVEE OF THE SACRAMENTO RIVER BETWEEN COURTLAND AND FREEPORT, SACRAMENTO COUNTY.
