27. PROPOSED MINERAL EXTRACTION LEASE, OWERS LAKE, INYO COUNTY: PITTSBURGH PLATE GLASS COMPANY - W.O. 5429, P.R.C. 3308.1.

After consideration of Calendar Item 27 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A MINERAL EXTRACTION LEASE TO THE PITTSBURGH PLATE GLASS COMPANY, THE HIGHEST QUALIFIED BIDDER, IN ACCORDANCE WITH THE PROVISIONS OF DIVISION 6 OF THE PUBLIC RESOURCES CODE, ON 91.11 ACRES MORE OR LESS OF SOVEREIGN LANDS IN OWENS LAKE, INVO COUNTY, MORE PARTICULARLY DESCRIBED IN EXHIBIT "A" ATTACHED AND HEREBY MADE A PART HEREOF, AT A ROYALTY RATE ON ALL MINERALS OR MINERAL PRODUCTS EXTRACTED FROM THE LEASED PREMISES AND SOLD, IN THE SUM OF \$0.50 PER TON, OR 2% OF THE VEIGHTED AVERAGE SALES PRICE, WHICHEVER IS THE GREATER, F.O.B. THE EXTRACTION PLANZ, FOR THE ACCRECATE OF ALL MINERALS AND MINERAL PRODUCTS EXTRACTED FROM THE LEASED PREMISES AND SOLD.

PROPOSED MINERAL EXTRACTION LEASE, OMENS LAKE, INYO COUNTY; PITTSBURGH WLATE GLASS COMPANY - W.O. 5429.

On April 15, 1965, one bid was received in response to a published Notice of Intention of the State Lands Commission to enter into a lease for mineral extraction and as a right-of-way on five parcels covering an area 100 feet wide and 39,688.68 feet long, containing a total of 91.11 acros more or less in the dry bed of Ovens Lake, located in portions of Sections 20, 21, 22, 27, 28, 29, 32, 34, and 35, 7, 17 S., R. 37 E., and a portion of Section 3, T. 18 S., R. 37 E., M.D.B.& M., Inyo County, designated as W.O. 5429. (Exhibit "C") This offer was authorized by the Commission on February 25, 1955. Minerals will be catracted from brine produced by wells drilled alorg the right-of-way and into the bed of Ovens Lake.

The bidder, Pittsturgh Flace (Lass Company, who is currently operating State leases on Owens Lake, offered a royalty of \$0.50 per ton, or 2% of the weighted average sales price, whichever is greater, f.o.b. the ext action plant, for all mineral products extracted from the leased premises and sold. The bid submitted was reviewed by the staff as to technical sufficiency and economic factors; the office of the Attorney General has determined that it conforms with the requirements set forth in the lease offer, the applicable provisions of law, and the rules and regulations of the Company.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A MINERAL EXTRACTION LEASE TO THE PITTSBURGH PLATE GLASS COMPANY, THE HIGHEST QUALIFIED BIDDER, IN ACCORDANCE WITH THE PROVISIONS OF DIVISION 6 OF THE PUBLIC RESOURCES CODE, ON 91.11 ACRES MORE OR LESS OF SOVEREIGN LANDS IN OWENS LAKE, INYC COUNTY, MORE PARTICULARLY DESCRIBED IN EXHIBIT "A" ATTACHED AND HEREBY MADE A PART HEREOF, AT A ROYALTY HATE ON ALL MINERALS OR MINERAL PRODUCTS EXTRACTED FROM THE LEASED PREMISES AND SOLD, IN THE SUM OF \$0.50 PER TON, OR 25 OF THE WEIGHTED AVERAGE SALES PRICE, WHICHEVER IS THE GREATER, F.O.B. THE EXTRACTION PLANT, FOR THE AGGREGATE OF ALL MINERALS AND MINERAL PRODUCTS EXTRACTED FROM THE LEASED PREMISES AND SOLD.
