4. APPLICATION FOR THREE-MONTH RIGHT-OF-ENTRY PERMIT TO REMOVE DEBRIS FROM THE BED OF THE EEL RIVER NEAR RIO DELL, HUMBOLDT COUNTY; DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS - W.O. 5644, P.R.C. 3318.9.

After consideration of Calendar Item 28 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, A THREE-MONTH RIGHT-OF-ENTRY PERMIT IN THE BED OF THE EEL RIVER, IN THE VICINITY OF RIO DELL, FOR THE PURPOSE OF REMOVING DEBRIS WITHIN THAT AREA. THE PERMIT SHALL BE IN THE FORM SET FORTH AS EXHIBIT "B" ATTACHED HERETO AND MADE A PART HEREOF. THE CONSIDERATION IS THE PUBLIC BENEFIT.

APPLICATION FOR THREE-MONTH RIGHT-OF-ENTRY PERMIT TO REMOVE DEBRIS FROM THE BED OF THE EEL RIVER NEAR RIO DELL, HUMBOLDT COUNTY; DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS - W.O. 5644.

The California Department of Public Works, Division of Highways, has requested a temporary right-of-entry permit to remove debris from the bed of the Eel river, approximately 1.9 miles north of Rio Dell, as shown on Exhibit "A".

The debris to be removed consists largely of steel girders and concrete piers of the former Paul Mudgett Bridge, which was destroyed by winter floods. The presence of this debris constitutes a hazard to public health, safety, and navigation. Removal is therefore in the public interest.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, A THREE-MONTH RIGHT-OF-ENTRY PERMIT IN THE BED OF THE EEL RIVER, IN THE VICINITY OF RIO DELL, FOR THE PURPOSE OF REMOVING DEBRIS WITHIN THAT AREA. THE PERMIT SHALL BE IN THE FORM SET FORTH AS EXHIBIT "B" ATTACHED HERETO AND MADE A PART HEREOF. THE CONSIDERATION IS THE PUBLIC BENEFIT.
