PROFOSAL OF THE CITY OF LONG BEACH TO EXFEND TIDELAND OIL REVENUES FOR THE CONSTRUCTION OF A BEACH PARKING LOT, 16TH-20TH PLACE -- L.B.W.O. 10,202.

The Commission, on October 22, 1964, made determination that the proposed expenditure by the City of Long Beach of approximately \$275,000 from its share of tideland oil revenues for the construction of a parking lot on and adjacent to Long Beach tidelands south of Bixby Park is in accordance and conformance with the provisions of Chapter 138, Statutes of 1964, 1st Extraordinary Session, said determination being subject to the condition that the work conform in essential details to the plans and background material previously submitted.

The City Attorney. in letter dated May 19, 1965, has advised that the cost of the work is now anticipated to be \$330,000, based upon an estimate by the consulting engineer, who has completed the preliminary plans. The City Attorney further advises, and the staff is in agreement, that the preliminary plans conform in essential respects to the information which was previously supplied to the Commission. The change in estimated cost results from recalculation of physical quantities on the more detailed plans as well as a new item, contractor's overhead and profit, in the amount of \$38,095, which is considered as fifteen percent of the job cost. Refer to Exhibits "A", "B", "C", and "D" for the new estimate and a description of the work.
