Lease P.R.C. 2364.2, covering Lot 4 and the  $W_2^1$  of Lot 2, Section 36, T. 1 N., R. 1 W., M.D.B.& M., on Mt. Diablo in Contra Costa County, was issued to Lindsey H. Spight, d.b.a. Diablo Communications Center, for 15 years beginning March 16, 1959. The lessee is authorized to sublease, subject to prior approval by the Commission.
