THE COMMISSION APPOINTS THE CHAIRMAN TO SERVE AS A MEMBER OF THE SAN FRANCISCO BAY CONSERVATION AND DEVELOPMENT COMMISSION AND AUTHORIZES THE CHAIRMAN, AS THE DESIGNATED MEMBER, TO AUTHORIZE THE EXECUTIVE OFFICER TO SERVE AS PROXY.

APPOINTMENT OF STATE LANDS COMMISSION MEMBER AND PROXY TO THE SAN FRANCISCO BAY CONSERVATION AND DEVELOPMENT COMMISSION - W.O. 5762.

Senate Bill 309 (McAteer) introduced during the 1965 Regular Legislative Session, was approved and signed by the Governor on July 12, 1965. This bill has been designated as Chapter 1162 and will become law on September 17, 1965.

Chapter 1162, Statutes of 1965, adds Title 7.2 (commencing with Section 66600) to the Government Code and provides for the creation of the San Francisco Bay Conservation and Development Commission.

Section 66620 of the Government Code provides for the designation of the members of the Conservation and Development Commission as follows:

One representative each for:

- (a) The United States Army Corps of Engineers.
- (b) The U. S. Department of Health, Education and Welfare.
- (c) The State Lands Commission.
- (d) The San Francisco Bay Regional Water Pollution Control Board.
- (e) The Bay Area Transportation Study Commission.

The Administrator of Highway Transportation.

The State Planning Officer.

The Administrator of the Resources Agency.

Nine county representatives, consisting of one resident of each of the nine San Francisco Bay area counties, appointed by the board of supervisors in each county.

Three representatives of cities, appointed by $t \in Association$ of Bay Area Governments.

Seven representatives of the public, whose appointments shall be subject to confirmation by the Senate. Five of such representatives shall be appointed by the Governor, one by the Committee on Rules of the Senate, and one by the Speaker of the Assembly. These members of the commission shall be residents of the San Francisco Bay area.

Section 66622 of the Government Code (relating to the Conservation and Development Commission) provides that:

SUPPLEMENTAL CALENDAR ITEM 42. (CONTD.)

"The members of the commission shall serve at the pleasure of their respective appointing powers. The members shall serve without compensation, but each of the members shall be remoursed for his necessary expenses incurred in the performance of his duties. A member may authorize no more than one proxy for attendance at meetings or for voting, which proxy shall be designated, in writing, at the time the member is appointed to the commission. The name of the proxy shall be filed with the commission."

Pursuant to statute, the first meeting of the Conservation and Development Commission must be held no later than ten days after the effective date of Chapter 1162 (i.e., September 27, 1965).

IT IS RECOMMENDED THAT THE COMMISSION APPOINT THE CHAIRMAN TO SERVE AS A MEMBER ON THE SAN FRANCISCO BAY CONSERVATION AND DEVELOPMENT COMMISSION AND TO AUTHORIZE THE CHAIRMAN, AS THE DESIGNATED MEMBER, TO AUTHORIZE THE EXECUTIVE OFFICER TO SERVE AS PROXY.
