7. APPLICATION FOR EXTENSION OF TERM OF DREDGING PERMIT, CORTE MADERA CREEK, MARIN COUNTY; LEE R. MILLER - W.O. 5884, P.R.C. 2716.1.

After consideration of Calendar Item 32 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXTEND THROUGH DECEMBER 31, 1967, THE PERIOD OF DREDGING PERMIT P.R.C. 2716.1, WHICH COVERS A PORTION OF THE BED OF CORTE MADERA CREEK LYING BELOW THE HIGH WATER MARK DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF THE P. L. MILLER PROPERTY, SAID PROPERTY BEING A PORTION OF LOT 44, HUGH PORTER SUBDIVISION; THENCE PROCEEDING NORTHEASTERLY ALONG THE PROJECTION OF THE WESTERLY BOUNDARY OF SAID PROPERTY 30 FEET MORE OR LESS TO A POINT ON THE LOWER LOW WATER LINE; THENCE SOUTHEASTERLY ALONG SAID LOWER LOW WATER LINE 56.22 FEET; THENCE SOUTHWESTERLY 30 FEET MORE OR LESS TO THE NORTHEAST CORNER OF SAID P. L. MILLER PROPERTY; THENCE NORTHWESTERLY ALONG THE NORTHEAST BOUNDARY OF SAID PROPERTY TO THE POINT OF BEGINNING, SAID PARCEL CONTAINING 0.039 ACRE MORE OR LESS IN MARIN COUNTY.

THE EXTENSION OF DREDGING PERMIT P.R.C. 2716.1 IS SUBJECT TO THE CONDITION THAT THE DREDGED MATERIAL BE DEPOSITED IN SAN FRANCISCO BAY EASTERLY FROM BLUNT POINT, ANGEL ISLAND.

APPLICATION FOR EXTENSION OF TERM OF DREDGING PERMIT, CORTE MADERA CREEK, MARIN COUNTY; LEE R. MILLER - W.O. 5884, P.R.C. 2716.1.

On April 12, 1961 (Minute Item 6, page 6822), the State Lands Commission authorized Lee R. Miller to dredge, during the period April 12, 1961, through December 31, 1964, at a royalty of three cents per cubic yard, approximately 150 cubic yards of material from a portion of the bed of Corte Madera Creek lying below the high water mark. On December 17, 1964, the permit was extended through December 31, 1965.

An application has been submitted by Lee R. Miller, requesting additional time within which to complete the dredging. According to the applicant, several attempts have been made in the past to employ a dredge, but, due to the limited amount of dredging to be done, none of the dredging firms will agree to make a special trip there to do the work. He now proposes to accomplish the dredging manually, and hopes to complete the work within several months.

The Department of the Army permit issued by the Corps of Engineers, authorizing the proposed dredging and also authorizing spoil deposition in San Francisco Bay easterly of Blunt Point, Angel Island, expires December 31, 1967. Mr. Miller has requested that subject dredging permit be extended to coincide with that date.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO EXTEND THROUGH DECEMBER 31, 1967, THE PERIOD OF DREDGING PERMIT P.R.C. 2716.1, WHICH COVERS A PORTION OF THE BED OF CORTE MADERA CREEK LYING BELOW THE HIGH WATER MARK DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF THE P. L. MILLER PROPERTY, SAID PROPERTY BEING A PORTION OF LOT 44, HUGH PORTER SUBDIVISION; THENCE PROCEEDING NORTHEASTERLY ALONG THE PROJECTION OF THE WESTERLY BOUNDARY OF SAID PROPERTY 30 FEET MORE OR LESS TO A POINT ON THE LOWER LOW WATER LINE, THENCE SOUTHEASTERLY ALONG SAID LOWER LOW WATER LINE 56.22 FEET; THENCE SOUTHWESTERLY 30 FEET MORE OR LESS TO THE NORTHEAST CORNER OF SAID P. L. MILLER PROPERTY; THENCE NORTHWESTERLY ALONG THE NORTHEAST BOUNDARY OF SAID PROPERTY TO THE POINT OF BEGINNING, SAID PARCEL CONTAINING 0.039 ACRE MORE OR LESS IN MARIN COUNTY.

THE EXTENSION OF DREDGING PERMIT P.R.C. 2716.1 TO BE SUBJECT TO THE CONDITION THAT THE DREDGED MATERIAL BE DEPOSITED IN SAN FRANCISCO BAY EASTERLY FROM BLUNT POINT, ANGEL ISLAND.
