16. WITHDRAWAL OF PROSPECTING PERMIT FOR GEOTHERMAL EMERGY, LAKE COUNTY, EUGENE SULLY HANCOCK, JR. - W.O. 5166.

After consideration of Calendar Item 12 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION RESCINDS THE JULY 20, 1965, AUTHORIZATION FOR THE EXECUTIVE OFFICER TO ISSUE TO EUGENE SULLY HANCOCK, JR., A TWO-YEAR PROSPECTING PERMIT AUTHORIZING PROSPECTING FOR GEOTHERMAL ENERGY, FOR MINERAL WATERS, FOR NONHYDROCARBON GASES, AND FOR ALL MINERALS OTHER THAN OIL AND GAS ON SUB-MERGED LANDS UNDERLYING CLEAR LAKE IN LAKE COUNTY AS DESCRIBED IN EXHIBIT "A" ATTACHED.

WITHDRAWAL OF PROSPECTING PERMIT FOR GEOTHERMAL ENERGY, LAKE COUNTY, EUGENE SULLY HANCOCK, JR. - W.O. 5166.

An application was received on May 20, 1964, from Eugene Sully Hancock, Jr., an individual, for a permit to prospect for geothermal energy, for all minerals other than oil and gas, and for mineral waters on submerged lands underlying Clear Lake in portions of Section 6, T. 13 N., R. 7 W., and Sections 1 and 2, T. 13 N., R. 8 W., M.D.B.& M., Lake County.

On July 20, 1965 (Minute Item 11, page 11,495), pursuant to Section 6891 of the Public Resources Code, the Commission authorized the Executive Officer to issue to Eugene Sully Hancock, Jr., a two-year prospecting permit for secthermal energy, for mineral waters, for nonhydrocarbon gases, and for all minerals other than oil and gas, in 285 acres of submerged lands underlying Clear Lake, Lake County.

On July 22, 1965, the permit was transmitted to the applicant, Eugene Sully Hancock, Jr. He has declined to execute acceptance of the permit, and there is no indication that he will accept the permit. He has been advised that action would be taken to rescind the authorization of a permit.

IT IS RECOMMENDED THAT THE COMMISSION RESCIND THE JULY 20, 1965, AUTHORIZATION FOR THE EXECUTIVE OFFICER TO ISSUE TO EUGENE SULLY HANCOCK, JR., A TUO-YEAR PROSPECTING PERMIT AUTHORIZING PROSPECTING FOR GEOTHERMAL ENERGY, FOR MINERAL WATERS, FOR NONHYDROCARBON GASES, AND FOR ALL MINERALS OTHER THAN OIL AND GAS ON SUBMERCED LANDS UNDERLYING CLEAR LAKE IN LAKE COUNTY AS DESCRIBED IN EXHIBIT "A" ATTACHED.
