HE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO ELROY A. RICHARDSON, FOR THE FEE OF \$25, A FIVE-YEAR RECREATIONAL PIER PERMIT FOR THE CONSTRUCTION OF A FLOAT OVER THE LAND DESCRIBED AS FOLLOWS:

A PARCEL OF SUBMERGED LAND IN THE COLORADO RIVER, RIVERSIDE COUNTY, APPROXIMATELY 1-3/4 MILES SOUTH OF BLYZHE, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

APPLICATION FOR RECREATIONAL MINOR-STRUCTURE PERMIT, SOVEREIGN LAND IN THE COLORADO RIVER, RIVERSIDE COUNTY; ELROY A. RICHARDSON - W.O. 5925.

Elroy A. Richardson, lessee of the adjacent upland, has applied for a recreational minor-structure permit to construct a 6' x 10' float on 0.003-acre parcel of sovereign land in the bed of the Colorado River, 1-3/4 miles south of Blythe in Riverside County (as shown on Exhibit "A").

The upland has been leased to the applicant by Colcrado River Properties Inc., for a term ending December 31, 1990.

Mr. Richardson has applied to the U.S. Department of the Army, Corps of Engineers, for a navigational permit to construct the float.

A fee of \$25 will be charged for a 5-year term. A performance bond will not be required.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO ELROY A. RICHARDSON, FOR THE FEE OF \$25, A FIVE-YEAR RECREATIONAL PIER PERMIT FOR THE CONSTRUCTION OF A FLOAT OVER THE LAND DESCRIBED AS FOLLOWS:
