APPLICATION FOR PERMIT TO ENTER STATE SCHOOL LAND IN SAN DIEGO COUNTY FOR TEST BORINGS; STATE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS -W.O. 5939.

The Division of Highways has requested authority to take test borings for material samples, to construct equipment trails and to conduct surveys in Section 36, T. 15 S., R. 3 E., S.B.B.& M., as shown on Exhibit "B".

The project is preliminary to the construction of Interstate Route 8 between San Diego and El Centro. It is anticipated that the borings and survey will continue for a period of six months from January 3, 1966.

> Subject: Permit to Take Test Borings and Conduct Surveys on State School Lands in San Diego County.

Permission is hereby granted to enter upon the land situated in the NW_{4}^{1} of NW_{4}^{1} of Section 36, T. 15 S., R. 3 E., S.B.B.& M., San Diego County, for the purpose of performing the following work, to wit:

a. Test borings to determine subsurface conditions.

b. Construction of dozer trails to provide access for equipment.

c. Conduct of preliminary surveys.

In consideration of the permission granted herein, the Division of Highways agrees:

- 1. That the area where the State performs sold borings will be left in a neat and safe condition.
- 2. That all fences which may be removed for the passage of equipment will be restored to their original condition.
- 3. That the Division of Highways will pay the cost of any damage to the land which may result by reason of the work performed hereunder.
- 4. The rights and privileges hereby granted may, at the option of the permittee, be exercised by any agent or contractor of the State; provided, however, that the State Lands Commission will be advised in writing of the name of the agent or contractor, and further, that the Division of Highways agrees that the conditions contained in this permit shall be made a part of any contract with such agent or contractor.
- 5. This agreement shall be effective for a period of six months and then only when executed by the Executive Officer of the State Lands Commission.
