APPLICATION FOR SUBMARINE CABLE EASEMENT ACROSS UNGRANTED SOVEREIGN LANDS OF LITTLE POTATO SIGUGH, SAN JOAQUIN COUNTY; EL CAMINO BOAT CLUB, INC. - W.O. 5779.

El Camino Boat Club, Inc., owner of El Camino Island located about 15 miles NE of Stockton in San Joaquin County (see Exhibit "A"), has applied to lease a 0.054-acre strip of sovereign land across Little Potato Slough for the installation of a submarine electrical cable.

The Reclamation Board has approved the installation of a power pole on the levee side of the slough for a take-off of service from the Pacific Cas and Electric Company lines. A request for a U. S. Army Corps of Engineers navigational permit has been affirmatively processed through the State Resources Agency.

The minimum rental of \$100 will apply for an initial lease term of 15 years; the lease will provide for three renewal options of ten years each.
