3. APPLICATION FOR TEMPORARY RIGHT-OF-ENTRY PERMIT, SOVEREIGN LAND OF EEL RIVER AT RIO DELL, HUMBOLDT COUNTY; STATE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS - W.O. 5978, P.R.C. 3444.9.

After consideration of Calendar Item 4 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A TEMPORARY RIGHT-OF-ENTRY PERMIT, IN CONSIDERATION OF THE PUBLIC INTEREST, TO THE STATE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, FOR THE REMOVAL OF A DESTROYED BRIDGE STRUCTURE AND RELATED DEBRIS FROM UNGRANTED SOVEREIGN LAND IN THE BED OF THE EEL RIVER AT THE NORTH CITY LIMITS OF RIO DEL, IN SECTION 31, T. 2 N., R. 1 W., H.B.& M., HUMBOLDT COUNTY; THE PERMIT TO TERMINATE ON THE DATE THE DIVISION OF HIGHWAYS REPORTS THE REMOVAL COMPLETED.

APPLICATION FOR TEMPORARY RIGHT-OF-ENTRY PERMIT, SOVEREIGN LAND OF EEL RIVER AT RIO DELL, HUMBOLDT COUNTY; STATE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS - W.C. 5978.

The Department of Public Works, Division of Highways, has applied for a temporary right-of-entry permit to occupy ungranted sovereign land in the Eel River at Rio Dell in Humboldt County (see Exhibit "A"), for the purpose of removing a destroyed bridge structure.

The destroyed bridge is being replaced by construction of the Paul Mudgett Memorial Bridge at the north city limits of Rio Dell. This matter will appear on the Commission's agenda as a separate item.

The permit will terminate when the Division of Highways reports completion of the removal project, estimated to be about September 1, 1966.
