5. APPLICATION FOR AUTHORITY TO ACCEPT QUITCLAIM DEED COVERING A PARCEL OF UNGRANTED SOVEREIGN LAND IN CARQUINEZ STRAIT, CONTRA COSTA AND SOLANO COUNTIES; STATE DEPARTMENT OF PUBLIC WORKS (DIVISION OF HIGHWAYS) - W.O. 5633.

After consideration of Calendar Item 19 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ACCEPT, EFFECTIVE FEBRUARY 24, 1966, DIRECTOR'S DEED (QUITCLAIM) FROM THE STATE DEPARTMENT OF PUBLIC WORKS AND APPROVED BY THE CALIFORNIA HIGHWAY COMMISSION ON OCTOBER 20, 1965, CONVEYING ITS LEASEHOLD INTEREST IN LEASE P.R.C. 965.9, COVERING TWO PARCELS OF SOVEREIGN LAND IN CARQUINEZ STRAIT AT MARTINEZ, CONTRA COSTA AND SOLANO COUNTIES.

APPLICATION FOR AUTHORITY TO ACCEPT QUITCLAIM DEED COVERING A PARCEL OF UNGRANTED SOVEREIGN LAND IN CARQUINEZ STRAIT, CONTRA COSTA AND SOLANO COUNTIES; STATE DEPARTMENT OF PUBLIC WORKS (DIVISION OF HIGHWAYS) - W.O. 5633.

A quitclaim deed has been received from the Division of Highways covering two parcels of sovereign land in Carquinez Strait, being the municipal wharf site at the City of Martinez and a nearby ferry approach area in the strait. The deed terminates Lease P.R.C. 965.9, which was issued March 26, 1954, for the operation of the old Martinez-Benicia Ferry.
