11. APPLICATION FOR EXTENSION OF TERM OF DREDGING PERMIT, BODEGA BAY, SONOMA COUNTY; LEON O. MASON - W.O. 5950, P.R.C. 2883.9.

After consideration of Calendar Item 37 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXTEND THROUGH DECEMBER 31, 1968, THE PERIOD OF DREDGING PERMIT P.R.C. 2883.9, WHICH COVERS AN AREA OF TIDE AND SUBMERGED LANDS DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT ON THE ORDINARY HIGH WATER MARK OF BODEGA HARBOR, SAID POINT LOCATED S. 15° 31' 27" EAST A DISTANCE OF 164.03 FEET FROM STATION 207 AS SHOWN ON THE LEGISLATIVE GRANT TO THE COUNTY OF SONOMA, RECORDED IN BOOK 71 OF MAPS, PAGE 4 THROUGH 9, SONOMA COUNTY RECORDS; THENCE FROM SAID POINT OF COMMENCEMENT NORTH 72° 14' 40" EAST A DISTANCE OF 150 FEET TO THE POINT OF BEGIN-NING; THENCE FROM SAID TRUE POINT OF BEGINNING AND CONTINUING NORTH 72° 14' 40" EAST A DISTANCE OF 200 FEET TO A POINT; THENCE SOUTH 17° 45' 20" EAST A DISTANCE OF 751 FEET TO A POINT; THENCE SOUTH 72° 14' 40" WEST A DISTANCE OF 200 FEET TO A POINT; THENCE SOUTH 17° 45' 20" EAST A DISTANCE OF 751 FEET TO A POINT; THENCE NORTH 17° 45' 20" WEST A DISTANCE OF 751 FEET TO THE TRUE POINT OF BEGIN-NING, AND CONTAINING 3.45 ACRES MORE OR LESS.

ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN UNCHANCED AND IN FULL FORCE AND EFFECT.

APPLICATION FOR EXTENSION OF TERM OF DREDGING PERMIT, BODEGA BAY, SONOMA COUNTY; LEON 0. MASON - W.O. 5950, P.R.C. 2883.9.

On May 24, 1962 (Minute Item 5, page 7963), the State Lands Commission authorized Leon 0. Mason to dredge, during the period May 24, 1962, to December 31, 1965, without payment of royalty, an estimated 12,000 cubic yards of material from an area of granted tide and submerged lands in Bodega Bay, Sonoma County.

An application has been submitted by Leon O. Mason requesting additional time within which to complete the dredging. According to the applicant, the requested dredging has not been performed due to the construction of the west shore road in the Bodega Bay area and to fill within the marina by the County of Sonoma which requires much time to settle.

The Department of the Army Permit issued by the Corps of Engineers, authorizing the proposed dredging, expired on December 31, 1965; however, an Extension of Time permit issued by the Corps of Engineers extended the time limit to December 31, 1968.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO EXTEND THROUGH DECEMBER 31, 1968, THE PERIOD OF DREDGING PERMIT P.R.C. 2883.9, WHICH COVERS AN AREA OF TIDE AND SUBMERGED LANDS DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT ON THE ORDINARY HIGH WATER MARK OF BODEGA HARBOR, SAID POINT LOCATED S. 15° 31' 27" EAST A DISTANCE OF 164.03 FEET FROM STATION 207 AS SHOWN ON THE LEGISLATIVE GRANT TO THE COUNTY OF SONOMA, RECORDED IN BOOK 71 OF MAPS, PAGE 4 THROUGH 9, SONOMA COUNTY RECORDS; THENCE FROM SAID POINT OF COMMENCEMENT NORTH 72° 14' 40" EAST A DISTANCE OF 150 FEET TO THE TRUE POINT OF BEGINNING; THENCE FROM SAID TRUE POINT OF BEGINNING AND CONTINUING NORTH 72° 14' 40" EAST A DISTANCE OF 200 FEET TO A POINT; THENCE SOUTH 17° 45' 20" EAST A DISTANCE OF 751 FEET TO A POINT; THENCE SOUTH 17° 45' 20" EAST A DISTANCE OF 751 FEET TO A POINT; THENCE SOUTH 72° 14' 40" FEET TO THE TRUE POINT OF BEGINNING, AND CONTAINING 3.45 ACRES MORE OR LESS.

ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
