45. SERVICE AGREEMENT, CHAPTER 57, STATUTES 1915, CITY OF REDONDO BEACH, COUNTY OF LOS ANGELES - W.O. 5740, GEO.-LOS ANGELES CO., P & C.

After consideration of Calendar Item 29 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

SERVICE AGREEMENT CHAPTER 57, STATUTES 1915, CITY OF REDONDO BEACH, COUNTY OF LOS ANGELES - W.O. 5740 .

Chapter 57, Statutes 1915, conveys certain described tide and submerged lands to the City of Redondo Beach.

Section 6359 of the Public Resources Code provides that the State Lands Commission shall survey, monument, and record a plat of any tide and submerged lands granted by the Legislature.

The work for the City of Redondo Beach is to be performed on a contract basis, and an agreement has been drawn that provides for the rendering of the surveying services by the State Lands Division as its estimated cost of not to exceed \$980.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO EXECUTE A SERVICE AGREEMENT WITH THE CITY OF REDONDO BEACH, CALIFORNIA, ON BEHALF OF THE STATE LANDS COMMISSION AS CONTRACTOR, PROVIDING FOR SURVEYING AND PLATTING SERVICES TO BE RENDERED IN CONNECTION WITH TIDE AND SUBMERGED LANDS GRANTED TO SAID CITY PURSUANT TO THE PROVISIONS OF CHAPTER 57, STATUTES OF 1915, THE PAYMENT TO THE STATE LANDS COMMISSION FOR SAID SERVICES TO BE THE STATE LANDS DIVISION'S ACTUAL COSTS NOT TO EXCEED \$980.
