19. APPLICATION FOR GEOLOGICAL SURVEY PERMIT; DEL NORTE, HUMBOLDT, MENDOCINO, SONOMA, MARIN, SAN FRANCISCO, SAN MATEO, SANTA CRUZ, MONTEREY, SAN LUIS OBISPO, SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE AND SAN DIEGO COUNTIES; CITIES SERVICE OIL COMPANY - W.O. 6041, P.R.C. 3470.1.

After consideration of Calendar Item 7 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO CITIES SERVICE OIL COMPANY A GEOLOGICAL SURVEY PERMIT, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOLOGICAL SURVEY OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN THE NORTHERN BOUNDARY AND SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM APRIL 1, 1966, THROUGH SEPTEMBER 30, 1966.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ANY INSPECTION COSTS.

An application has been received from Cities Service Oil Company, a Delaware corporation, for a permit to conduct geological survey operations in order to drill core holes in California State waters from the Oregon border to the Mexican border. The statutory filing fee has been paid by the applicant.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO CITIES SERVICE OIL COMPANY A GEOLOGICAL SURVEY PERMIT, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOLOGICAL SURVEY OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN THE NORTHERN BOUNDARY AND SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM APRIL 1, 1966, THROUGH SEPTEMBER 30, 1966.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ANY INSPECTION COSTS.
