6. APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, GALLINAS CREEK, MARIN COUNTY; DEPARTMENT OF PUBLIC WORKS - W.O. 5774, P.R.C. 3483.1.

After consideration of Calendar Item 31 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE MARIN COUNTY DEPARTMENT OF PUBLIC WORKS A PERMIT TO DREDGE APPROXIMATELY 208,360 CUBIC YARDS OF MATERIAL, AT A ROYALTY OF \$0.05 PER CUBIC YARD FOR ALL MATERIAL TO BE PLACED UPON PRIVATE PROPERTY, FROM THE FOLLOWING-DESCRIBED AREAS WITHIN THE BED OF GALLINAS CREEK WHICH LIE WITHIN THE 1959 LEGISLATIVE GRANT LINES FROM THE STATE OF CALIFORNIA TO THE COUNTY OF MARIN:

APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, GALLINAS CREEK, MARIN COUNTY; DEPARTMENT OF PUBLIC WORKS - W.O. 5774.

An application has been received from the Department of Public Works, Marin County, for a permit to dredge for the improvement of navigation approximately 208,360 cubic yards of material from three separate areas within the bed of Gallinas Creek, covering 30.3 acres. Part of the area to be dredged lies within an area which has been granted to Marin County by the State of California, with a reservation to the State of all minerals.

Approximately 70,000 cubic yards of the dredged material will be placed upon County-owned property at the Civic Center Fairgrounds. The remainder of the material, 138,360 cubic yards, will be placed in two different disposal areas upon private lands. Dredging of the Creek will be at a depth of six feet at mean lower low water, and total length will be approximately 2.5 miles from its mouth at San Pablo Bay near San Rafael.

Section 6303 of the Public Resources Code provides that the Commission may grant the privilege of removing or extracting material from tide or submerged lands owned by the State for the improvement of navigation or reclamation, upon such terms and conditions and for such consideration as will be for the best interests of the State.

The U. S. Army Corps of Engineers has issued a Department of the Army permit authorizing the conduct of dredging operations at the location described in the application. The Division of Beaches and Parks has reported that issuance of the permit would have no effect upon any program or project of that Department, and that there are no known recreational activities on their land or lands littoral that would be adversely affected. The California Reclamation Board has approved the proposed dredging. The Department of Fish and Game has stated that it has no objection to the issuance of the permit.

The San Francisco Bay Conservation and Development Commission has approved the proposed dredging.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE MARIN COUNTY DEPARTMENT OF PUBLIC WORKS A PERMIT TO DREDGE APPROXIMATELY 208,360 CUBIC YARDS OF MATERIAL, AT A ROYALTY OF \$0.05 PER CUBIC YARD FOR ALL MATERIAL TO BE PLACED UPON PRIVATE PROPERTY, FROM THE FOLLOWING-DESCRIBED AREAS WITHIN THE BED OF GALLINAS CREEK WHICH LIE WITHIN THE 1959 LEGISLATIVE GRANT LINES FROM THE STATE OF CALIFORNIA TO THE COUNTY OF MARIN:
