9. APPLICATION FOR RECREATIONAL MINOR-STRUCTURE PERMIT, SOVEREIGN LAND IN THE COLORADO RIVER, SAN BERNARDINO COUNTY; LUIGI V. DI FILLIPPO - W.O. 6065, P.R.C. 3478.1.

After consideration of Calendar Item 27 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO LUIGI V. DI FILLIPPO A FIVE-YEAR RECREATIONAL PERMIT FOR THE CONSTRUCTION OF A FLOAT OVER THE FOLLOWING-DESCRIBED LAND:

A PARCEL OF SUBMERGED LAND IN THE BED OF THE COLORADO RIVER, SAN BERNARDINO COUNTY, CALIFORNIA, SITUATE NEAR EARP, CALIFORNIA, BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT THE INTERSECTION OF THE EASTERLY LINE OF LOT 7, BLOCK D, OF THE BLUE WATER SUBDIVISION, COLORADO RIVER INDIAN RESERVATION, WITH THE LOW WATER MARK OF THE RIGHT BANK OF THE COLORADO RIVER; SAID POINT OF INTERSECTION BEARS SOUTHERLY ALONG THE $\frac{1}{4}$ SECTION LINE OF SECTION 10, T. 1 N., R. 26 E., 1,070 FEET MORE OR LESS AND EASTERLY ALONG THE RIGHT BANK OF THE COLORADO RIVER APPROXIMATELY 400 FEET FROM THE CENTER OF ABOVEMENTIONED SECTION 10; THENCE FROM THE POINT OF BEGINNING PROCEEDING SOUTHERLY NORMAL TO THE RIGHT BANK 30 FEET; THENCE WESTERLY PARALLEL TO THE LOW WATER MARK 40 FEET; THENCE NORTHERLY NORMAL TO THE RIGHT BANK 30 FEET TO THE LOW WATER MARK; THENCE EASTERLY ALONG SAME TO THE POINT OF BEGINNING; CONTAINING 0.028 ACRE MORE OR LESS.

APPLICATION FOR RECREATIONAL MINOR-STRUCTURE PERMIT, SOVEREIGN LAND IN THE COLORADO RIVER, SAN BERNARDINO COUNTY; LUIGI V. DI FILLIPPO - W.O. 6065.

Luigi V. Di Fillippo, lessee of the adjacent upland, has applied for a recreational minor-structure permit to construct a 10' x 20' pier on a 0.028-acre parcel of sovereign land in the bed of the Colorado River near Earp, California (as shown on Exhibit "A").

The applicant has leased the upland from the Bureau of Indian Affairs for a term ending in 1990.

A U. S. Army Corps of Engineers navigational permit has been issued to Mr. Di Fillippo.

A fee of \$25 will be charged for a 5-year term.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO LUIGI V. DI FILLIPPO A FIVE-YEAR RECREATIONAL PERMIT FOR THE CONSTRUCTION OF A FLOAT OVER THE FOLLOWING-DESCRIBED LAND:

A PARCEL OF SUBMERGED LAND IN THE BE OF THE COLORADO RIVER, SAN BERNARDINO COUNTY, CALIFORNIA, SITUATE NEAR EARP, CALIFORNIA, BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT THE INTERSECTION OF THE EASTERLY LINE OF LOT 7, BLOCK D, OF THE BLUE WATER SUBDIVISION, COLORADO RIVER INDIAN RESERVATION, WITH THE LOW WATER MARK OF THE RIGHT BANK OF THE COLORADO RIVER; SAID POINT OF INTERSECTION BEARS SOUTHERLY ALONG THE $\frac{1}{4}$ SECTION LINE OF SECTION 10, T. 1 N., R. 26 E., 1,070 FEET MORE OR LESS AND EASTERLY ALONG THE RIGHT BANK OF THE COLORADO RIVER APPROXIMATELY 400 FEET FROM THE CENTER OF ABOVEMENTIONED SECTION 10; THENCE FROM THE POINT OF BEGINNING PROCEEDING SOUTHERLY NORMAL TO THE RIGHT BANK 30 FEET THENCE WESTERLY PARALLEL TO THE LOW WATER MARK 40 FEET; THENCE NORTHERLY NORMAL TO THE RIGHT BANK 30 FEET TO THE LOW WATER MARK; THENCE EASTERLY ALONG SAME TO THE POINT OF BEGINNING; CONTAINING 0.028 ACRE MORE OR LESS.
