

40. PROPOSED LONG BEACH ANNEXATION INCREMENT NO. 205 (SUPERSEDING FORMER LONG BEACH ANNEXATION INCREMENT NO. 186), SUBMERGED TIDELANDS LYING SOUTHERLY OF THE CITY OF LONG BEACH BETWEEN THE CITY OF LOS ANGELES AND THE COUNTY OF ORANGE - W.O. 2400.39.

During consideration of Calendar Item 38 attached, the Executive Officer directed the Commission's attention to the fact that the recommended action would constitute only approval of the map of the proposed annexation area. Subsequent to such approval, the City of Long Beach will determine the next step to be taken in the annexation proceedings, after which an application to actually annex will be made. Therefore, in taking action at this time, the Commission would not be passing on the merits of the annexation, but only meeting the procedural requirements of the Government Code.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, THE FOLLOWING RESOLUTION WAS ADOPTED:

THE COMMISSION APPROVES THE PROPOSED OFFSHORE BOUNDARIES OF LONG BEACH ANNEXATION INCREMENT NO. 205 DESCRIBED AS FOLLOWS:

BEGINNING AT AN ANGLE POINT IN THE BOUNDARY OF THE CITY OF LONG BEACH, AS SAME EXISTED ON APRIL 1, 1966, SAID POINT BEING THE MOST SOUTHERLY SOUTHWESTERLY CORNER OF ANNEXATION OF NOVEMBER 10, 1909, TO THE CITY OF LONG BEACH AS FILED WITH THE SECRETARY OF STATE ON NOVEMBER 29, 1909 (IN SAN PEDRO BAY THREE MILES FROM THE COAST LINE OF THE PACIFIC OCEAN); THENCE NORTHEASTERLY ALONG SAID BOUNDARY OF THE CITY OF LONG BEACH AND FOLLOWING THE SAME IN ALL ITS VARIOUS COURSES AND CURVES TO THE COMMON BOUNDARY BETWEEN THE COUNTY OF LOS ANGELES AND THE COUNTY OF ORANGE, AS SAME EXISTED ON APRIL 1, 1966; THENCE SOUTHWESTERLY ALONG SAID COMMON BOUNDARY TO THE OWNERSHIP BOUNDARY OF THE STATE OF CALIFORNIA (AS DETERMINED ACCORDING TO THE DECREE ENTERED BY THE UNITED STATES SUPREME COURT IN UNITED STATES V. CALIFORNIA ORIGINAL NO. 5 ON JANUARY 31, 1966), AS SAME EXISTED ON APRIL 1, 1966; THENCE WESTERLY ALONG SAID LAST MENTIONED OWNERSHIP BOUNDARY TO THE EASTERLY BOUNDARY OF THE CITY OF LOS ANGELES, AS SAME EXISTED ON APRIL 1, 1966, BEING THE SOUTHERLY PROLONGATION OF THE WESTERLY LINE OF BLOCK 10 OF EAST SAN PEDRO AS SHOWN ON MAP RECORDED IN BOOK 52, PAGES 13 TO 18 INCLUSIVE, OF MISCELLANEOUS RECORDS IN THE OFFICE OF THE RECORDER OF THE COUNTY OF LOS ANGELES; THENCE NORTHERLY ALONG SAID LAST MENTIONED BOUNDARY TO THE POINT OF BEGINNING.

AND WILL INFORM THE CITY OF LONG BEACH AND THE EXECUTIVE OFFICER OF THE LOCAL AGENCY FORMATION COMMISSION OF SAID APPROVAL.

PROPOSED LONG BEACH ANNEXATION INCREMENT NO. 205 (SUPERSEDING FORMER LONG BEACH ANNEXATION INCREMENT NO. 186), SUBMERGED TIDELANDS LYING SOUTHERLY OF THE CITY OF LONG BEACH BETWEEN THE CITY OF LOS ANGELES AND THE COUNTY OF ORANGE - W.O. 2400.39.

The Division, by letter dated April 6, 1966, was informed that the City of Long Beach proposes to extend its corporate limits by annexation described as Long Beach Annexation Increment No. 205.

Section 35014 of the Government Code provides for approval or disapproval by the State Lands Commission of the boundaries of an annexation proposal where the annexation includes tide or submerged lands in the Pacific Ocean that are owned by the State, and for reporting its determination to the City and to the Executive Officer of the Local Agency Formation Commission.

Staff review of the map and the legal description of the proposed annexation has shown compliance with the provisions of said Section.

Map approval is required pursuant to Section 35014 of the Government Code. The map approval does not give approval by the State as owner of the tide and submerged lands to the proposed annexation. This matter will be the subject of separate later consideration by the Commission.

IT IS RECOMMENDED THAT THE COMMISSION APPROVE THE PROPOSED OFFSHORE BOUNDARIES OF LONG BEACH ANNEXATION INCREMENT NO. 205 DESCRIBED AS FOLLOWS:

BEGINNING AT AN ANGLE POINT IN THE BOUNDARY OF THE CITY OF LONG BEACH, AS SAME EXISTED ON APRIL 1, 1966, SAID POINT BEING THE MOST SOUTHERLY SOUTHWESTERLY CORNER OF ANNEXATION OF NOVEMBER 10, 1909, TO THE CITY OF LONG BEACH AS FILED WITH THE SECRETARY OF STATE ON NOVEMBER 29, 1909 (IN SAN PEDRO BAY THREE MILES FROM THE COAST LINE OF THE PACIFIC OCEAN); THENCE NORTHEASTERLY ALONG SAID BOUNDARY OF THE CITY OF LONG BEACH AND FOLLOWING THE SAME IN ALL ITS VARIOUS COURSES AND CURVES TO THE COMMON BOUNDARY BETWEEN THE COUNTY OF LOS ANGELES AND THE COUNTY OF ORANGE, AS SAME EXISTED ON APRIL 1, 1966; THENCE SOUTHWESTERLY ALONG SAID COMMON BOUNDARY TO THE OWNERSHIP BOUNDARY OF THE STATE OF CALIFORNIA (AS DETERMINED ACCORDING TO THE DECREE ENTERED BY THE UNITED STATES SUPREME COURT IN UNITED STATES V. CALIFORNIA ORIGINAL NO. 5 ON JANUARY 31, 1966), AS SAME EXISTED ON APRIL 1, 1966; THENCE WESTERLY ALONG SAID LAST MENTIONED OWNERSHIP BOUNDARY TO THE EASTERLY BOUNDARY OF THE CITY OF LOS ANGELES, AS SAME EXISTED ON APRIL 1, 1966, BEING THE SOUTHERLY PROLONGATION OF THE WESTERLY LINE OF BLOCK 16 OF EAST SAN PEDRO AS SHOWN ON MAP RECORDED IN BOOK 52, PAGES 13 TO 18 INCLUSIVE, OF MISCELLANEOUS RECORDS IN THE OFFICE OF THE RECORDER OF THE COUNTY OF LOS ANGELES; THENCE NORTHERLY ALONG SAID LAST MENTIONED BOUNDARY TO THE POINT OF BEGINNING.

AND INFORM THE CITY OF LONG BEACH AND THE EXECUTIVE OFFICER OF THE LOCAL AGENCY FORMATION COMMISSION OF SAID APPROVAL.
