APPLICATION FOR APPROVAL OF ASSIGNMENT OF LEASE P.R.C. 2363.1, TIDE AND SUBMERGED LANDS OF SAN JOAQUIN RIVER, APPPONIMATELY SEVEN MILES SOUTH OF STOCKTON, SAN JOAQUIN COUNTY; CATHERIN TUSSEY - W.O. 5979.

Lease P.R.C. 2363.1, covering a 0.100-acre site for a boating facility in the Sacramento River lying 0.2 mile upstream from the Brandt Bridge and 9 miles southwest of Stockton, was issued to Robert Barrymore on February 24, 1959, for a term of 15 years, at an annual rental of \$100.

The lease was assigned to R. A. Tussey on May 16, 1961, and amended on August 29, 1963, to indicate Catherin Tussey as surviving lessee.

Catherin Tussey has sold the upland to Roy and Velma F. Jacopetti and requests approval of an assignment of the lease covering the adjacent tide and submerged lands. A new bond in the amount of \$1000 has been provided, and the rent is paid through February 23, 1967.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO APPROVE THE ASSIGNMENT FROM CATHERIN TUSSEY TO ROY AND VEIMA F. JACOPETTI OF LEASE P.R.C. 2363.1, COVERING A 0.100-ACRE STRIP OF TIDE AND SUBMERGED LAND IN THE SAN JOAQUIN RIVER, SAN JOAQUIN COUNTY.
