Lease P.R.C. 2364.2, covering Lot 4 and the W2 of Lot 2, Section 36, T. 1 N., R. 1 W., M.D.B.& M., on Mt. Diablo in Contra Costa County, was issued to Lindsey H. Spight, d.b.a. Diablo Communications Center, for 15 years beginning March 16, 1959, at an annual rental of \$1,098, with provision for two renewal periods of 10 years each. The lessee is authorized to sublease, subject to prior approval by the Commission.

An application has been received for approval of a sublease to C & C Equipment Company for a portion of the leased site sufficient for the installation, maintenance, and operation of two mobile repeaters transmitting on 463.00/464.10 megacycles and receiving on 366.25/469.85 megacycles. The sublease, which is to run for an indefinite period not to exceed the term of Lease P.R.C. 2364.2, supersedes a sublease to C & C Equipment Company which was approved by the Commission on July 2, 1965 (Minute Item 11, page 11,362).
