On May 19, 1966, two bids were received in response to a published Notice of Intention of the State Lands Commission to enter into a lease for the extraction of oil and gas from approximately 4,570 acres of tide and submerged lands designated as W.O. 6033 (Parcel 33), Ventura County. A summary tabulation of the bonus-payment offers received pursuant to the lease proposal is attached as Exhibit "A".

Official notice has been received from Mobil that effective May 18, 1966, the corporate name was changed from Socomy Mobil Oil Company, Inc., to Mobil Oil Corporation.
