8. PROPOSED OIL AND GAS LEASE, SUBMERGED LANDS, SANTA BARBARA COUNTY -  
W.O. 6095 (PARCEL 39), P.R.C. 3498.1.

After consideration of Supplemental Calendar Item 7 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION ACCEPTS THE BID MADE BY STANDARD OIL COMPANY OF CALIFORNIA AND HUMBLE OIL & REFINING COMPANY ON JUNE 1, 1966, AND AUTHORIZES THE EXECUTIVE OFFICER TO ISSUE AN OIL AND GAS LEASE TO THE AFORESAID BIDDER FOR APPROXIMATELY 1,165 ACRES OF SUBMERGED LANDS DESIGNATED AS W.O. 6095 (PARCEL 39), IN SANTA BARBARA COUNTY, AS DETAILED IN THE NOTICE OF INTENTION, W.O. 6095, PUBLISHED APRIL 6, 1966, AND APRIL 13, 1966. THE CASH-BONUS PAYMENT IN CONSIDERATION OF ISSUANCE OF THE LEASE IS TO BE \$203,115.00 AS OFFERED IN THE BID.

PROPOSED OIL AND GAS LEASE, SUBMERGED LANDS, SANTA BARBARA COUNTY - W.O. 6095 (PARCEL 39).

On June 1, 1966, two bids were received in response to a published Notice of Intention of the State Lands Commission to enter into a lease for the extraction of oil and gas from approximately 1,165 acres of submerged lands designated as W.O. 6095 (Parcel 39), Santa Barbara County. This offer was authorized by the Commission on March 31, 1966 (Minute Item 33, page 12,450).

The bids submitted were reviewed by the staff as to technical sufficiency and economic factors. The office of the Attorney General reviewed the highest bid, submitted by Standard Oil Company of California and Humble Oil & Refining Company, and determined:

- A. That the Commission has complied with the procedural requirements of law;
- B. That the bid submitted conforms with:
  1. The bid requirements as specified in the proposals of the Commission;
  2. The applicable provisions of law; and
  3. The rules and regulations of the Commission.

A summary tabulation of the bonus-payment offers received pursuant to the lease proposal is attached as Exhibit "A".

IT IS RECOMMENDED THAT THE COMMISSION ACCEPT THE BID MADE BY STANDARD OIL COMPANY OF CALIFORNIA AND HUMBLE OIL & REFINING COMPANY ON JUNE 1, 1966, AND AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE AN OIL AND GAS LEASE TO THE AFORESAID BIDDER FOR APPROXIMATELY 1,165 ACRES OF SUBMERGED LANDS DESIGNATED AS W.O. 6095 (PARCEL 39), IN SANTA BARBARA COUNTY, AS DETAILED IN THE NOTICE OF INTENTION, W.O. 6095, PUBLISHED APRIL 6, 1966, AND APRIL 13, 1966.
