REQUEST FOR DEFERMENT OF DRILLING REQUIREMENTS, P.R.C. 3033.1, ORANGE COUNTY; UNION OIL COMPANY OF CALIFORNIA - W.O. 6175.

An application has been received from Union Oil Company of California, operator, requesting a deferment of drilling requirements for six months from July 25, 1966.

Oil and Gas Lease P.R.C. 3033-1, containing 2,113.245 acres more or less of submerged lands in Orange County, was issued July 25, 1963, to Union Oil Company of California, pursuant to competitive public bidding.

Union, as operator, in developing the lease, constructed a drilling platform and drilled 32 wells of which 4 have been redrilled to date. The last well to be drilled was completed on October 25, 1965. Thirty wells are currently producing.

The amount of the boxus bid paid by Union was \$6,110,000. Union has built a drilling and production platform which cost nearly \$4,000,000.

Union is currently evaluating the performance of the wells in order to determine the reservoir characteristics and the advisability of conducting further drilling operations.

In order to permit completion of the evaluation, Union has requested a six-month deferment.

Had Union fulfilled only the minimum drilling requirements of the lease, the present number of wells drilled would not have been completed until approximately May 29, 1979.

In conformance with current Commission practice of granting defermants of periods not in excess of six menths.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO GRANT TO UNION GIL COMPANY OF CALIFORNIA, OPERATOR, A DEFERMENT OF DRILLING REQUIREMENTS UNDER OIL AND GAS LEASE P.R.C. 3033.1 THROUGH JANUARY 25, 1967, WITH ALL OTHER TERMS AND CONDITIONS OF THE LEASE TO REMAIN IN FULL FORCE AND EFFECT.
