REQUEST FOR EXTENSION OF TERM, MINERAL EXTRACTION LEASE P.R.C. 210.1, PITTSBURGH PLATE GLASS COMPANY, INYO COUNTY - W.O. 5996.

Pursuant to competitive public bidding, on July 19, 1946, Mineral Extraction Lease P.R.C. 210.1, covering 82.8779 acres of land in the western part of Owens Lake, Inyo County, was issued to Pittsburgh Plate Glass Company, for a term of 20 years, for the purpose of taking and removing, and as a right-of-way for removing minerals other than oil and gas deposited therein and thereon and from the waters of Owens Lake.

An application has been received from Pittsburgh Plate Glass Company requesting an extension of the lease term from July 19, 1966, to July 18, 1976, inclusive. Section 1 of the lease provides the lessee in part with the preferential right "to renew this lease for successive periods of 10 years upon such reasonable terms and conditions as may be prescribed by the State Lands Commission." The royalty rate for minerals extracted and sold from the premises is \$0.50 per ton, or 2% of the weighted average sales price per ton f.o.b. lessee's plant at Bartlett, California, whichever is greater. Minimum extraction requirements are five tons of minerals per acre per year.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO EXTEND THE TERM OF MINERAL EXTRACTION LEASE P.R.C. 210.1, INYO COUNTY, AS REQUESTED BY THE LESSEE, PITTSBURGH PLATE GLASS COMPANY, FOR A PERIOD OF TEN YEARS COMMENCING JULY 19, 1966. ALL OTHER TERMS AND CONDITIONS OF THE LEASE ARE TO REMAIN IN FULL FORCE AND EFFECT.
