4. APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, PAJARO RIVER, SANTA CRUZ COUNTY; SANTA CRUZ COUNTY DEPARTMENT OR PUBLIC WORKS .. W.O. 6129, P.R.C. 3531.1.

After consideration of Calendar Item 24 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE SANTA CRUZ COUNTY DEPART-MENT OF PUBLIC WORKS A PERMIT TO DREDGE APPROXIMATELY 20,000 CUBIC YAXOS OF MATERIAL, AT A ROYALTY OF \$0.05 PER CUBIC YARD FOR ALL MATERIAL TO BE PLACED UPON PRIVATE PROPERTY, FROM THE FOLLOWING-DESCRIBED AREA MEAR THE MOUT! OF THE PAJARO RIVER IN THE COUNTY OF SANTA CRUZ:

SITUATE IN SECTION 25, TOWNSHIP 12 S., RANGE 1 E., COUNTY OF SANTA CRUZ, STATE OF CALIFORNIA.

BEING A PART OF LANOS CONVEYED TO THE STATE OF CALIFORNIA BY DEFT RECORDED IN VOLUME 1354 OF OFFICIAL RECORDS AT PAGE 14, SANTA CR62 COUNTY RECORDS.

BEGINNING AT A CORNER OF THE LANDS CONVEYED TO THE STATE OF CALI-FORNIA BY DEED RECORDED NOVEMBER 9, 1960, IN VOLUME 1354 OF OFFICIAL RECORDS AT PAGE 14, ET SEQUITUR, SANTA CRUZ COUNTY RECORDS, FROM WHICH THE UNITED STATES COAST AND GEODETIC TRIANCULATION STATION "PAJARO MOUTH NO. 3" BEARS NORTE 3° 11' 35" WEST 553.49 FEET DISTANT; THENCE ALONG THE BOUNDARIES OF THE LANDS CONVEYED TO THE STATE OF CALIFORNIA AS AFORESAID THE FOLLOWING COURSES AND DISTANCES:

NORTH 35° 10' 50" WEST, 153.24 FEET TO THE POINT OF INTER-SECTION WITH THE SOUTHWESTERLY PROLONGATION OF THE COURSE IDENTIFIED AS 1 ABOVE; THENCE LEAVING THE BOUNDARY OF THE SAID LANDS CONVEYED TO THE STATE OF CALIFORNIA NORTH 64° 01' 50" EAST 202.91 FEET TO THE POINT OF BEGINNING, CON-TAINING 16.622 ACRES.

THE PERMIT IS TO BE SUBJECT TO THE CONDITION THAT AFTER JUNE 23, 1967, PERMITTEE MUST SECURE APPROVAL FOR INGRESS AND EGRESS TO THE 14.5-ACRE PARCEL OF LAND UNDER JURISDICTION OF THE STATE DIVISION OF BEACHES AND PARKS THAT LIES BETWEEN THE DREDGE AND DISPOSAL AREAS.

APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, PAJARO RIVER, SANTA CRUZ COUNTY; SANTA CRUZ COUNTY DEPARTMENT OF PUBLIC WORKS - W.O. 6129.

An application has been received from the Department of Public Works, Santa Cruz County, for a permit to dredge approximately 20,000 cubic yards of sand from State-owned land at the mouth of the Pajaro River and place it upon adjacent privately owned land. The requested dredging is for the purpose of opening a channel at the mouth of the Pajaro River to provide stream flow from the river and its tributaries to Monterey Bay. The private property owners, Hare, Brewer, and Kelley, Inc., upon whose property the material is to be deposited, have consented to the placement of the material upon their property. In order to place the dredged material upon the private property, it will be necessary for the applicant to cross a certain portion of Sunset State Beach (see Exhibit "A").

Ection 6303 of the Public Resources Code provides that the Commission may grant the privilege of removing or extracting material from tide or submerged lands owned by the State for flood control upon such terms and conditions and for such consideration as will be for the best interests of the State.

The U. S. Army Corps of Engineers has issued a letter of permission authorizing the conduct of dreaging operations at the location described in the application. The Department of Parks and Recreation, Division of Beaches and Parks, has approved the dredging, and has submitted to the applicant certain conditions which will regulate ingress and egress to that portion of Sunset Beach which must be crossed during the course of the project. The permission to use that portion of the beach will not be valid after June 23, 1967.

The Department of Water Resources has indicated that the proposed depth of dredging will not be detrimental to the water resources and that they, therefore, have no objection to the project.

The Department of Fish and Game has reviewed the application, and has stated that the project will have no significant adverse effect upon fish or wildlife resources. It, therefore, has no objection to the permit.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE SANTA CRUZ COUNTY DEPARTMENT OF PUBLIC WORKS A FERMIT TO DREDGE APPROXIMATELY 20,000 CUBIC YARDS OF MATERIAL, AT A ROYALTY OF \$0.05 PER CUBIC YARD FOR ALL MATERIAL TO BE PLACED UPON PRIVATE PROPERTY, FROM THE FOLLOWING-DESCRIBED AREA NEAR THE MOUTH OF THE PAJARO RIVER IN THE COUNTY OF SANTA CRUZ:
