6. APPLICATION FOR PERMIT TO PLACE REGULATORY MARKER BUOYS AROUND PUBLIC BEACH LOCATIONS IN CLEAR LAKE, LAKE COUNTY; STATE DEPARTMENT OF PARKS AND RECREATION - W.O. 6138, P.R.C. 3532.9.

After consideration of Calendar Item 9 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO STATE DEPARTMENT OF PARKS AND RECREATION A FIFTEEN-YEAR PERMIT, IN CONSIDERATION OF THE PUBLIC BENEFIT, FOR THE PLACEMENT OF REGULATORY MARKER BUOYS AROUND PERIMETERS OF THE FOLLOWING-DESCRIBED PARCELS OF LAND:

THREE PARCELS OF SUBMERGED LAND 10 FEET WIDE IN CLEAR LAKE, LAKE COUNTY, ALL WITHIN SECTION 36, T. 14 N., R. 9 W., M.D.M., AND LYING 5 FEET ON EITHER SIDE OF THE FOLLOWING-DESCRIBED CENTERLINES:

PARCEL 1: BEGINNING AT A POINT IN THE BED OF CLEAR LAKE WHICH BEARS N.  $34^{\circ} 03'$  E., 4,353 FEET FROM A 2" x 2" HUB AND TACK AT CORNER COMMON TO SECTIONS 35 AND 36, T. 14 N., R. 9 W., M.D.M., AND SECTIONS 1 AND 2, T. 13 N., R. 9 W., M.D.M., AS SHOWN ON THE MAP FILED FOR RECORD, FEBRUARY 23, 1955, IN BOOK 1 OF SURVEYS, PAGE 86, LAKE COUNTY RECORDS, THENCE S.  $47^{\circ} 30'$  E., 50 FEET, S.  $43^{\circ} 30'$  E., 50 FEET, AND S.  $42^{\circ} 06'$  E., 50 FEET, CONTAINING 0.034 ACRE MORE OR LESS.

PARCEL 2: BEGINNING AT A POINT IN THE BED OF CLEAR LAKE WHICH BEARS N.  $60^{\circ} 52'$  E., 5,171 FEET FROM THE ABOVE-MENTIONED 2" x 2" HUB AND TACK, THENCE S.  $33^{\circ} 00'$  W., 50 FEET, S.  $11^{\circ} 30'$  W., 50 FEET, AND S.  $04^{\circ} 00'$  W., 50 FEET, CONTAINING 0.034 ACRE MORE OR LESS.

PARCEL 3: BEGINNING AT A POINT IN THE BED OF CLEAR LAKE WHICH BEARS N.  $65^{\circ} 34'$  E., 4,852 FEET FROM THE ABOVE-MENTIONED 2" x 2" HUB AND TACK, THENCE S.  $49^{\circ} 00'$  E., 50 FEET, CONTAINING 0.011 ACRE MORE OR LESS.

APPLICATION FOR PERMIT TO PLACE REGULATORY MARKER BUOYS AROUND PUBLIC BEACH LOCATIONS IN CLEAR LAKE, LAKE COUNTY; STATE DEPARTMENT OF PARKS AND RECREATION - W.O. 6138.

The Director, Department of Parks and Recreation, has applied for a permit to anchor regulatory marker buoys around Day Use Beach, Soda Bay Beach, and Mohi Beach, adjacent to Clear Lake State Park (as shown on Exhibit "A").

The markers are to define the limits of the swimming areas, and to prohibit boating within the perimeters.

The buoys will meet requirements of the California Boating Law. They will be held in place by chains attached to concrete block anchors, and spaced at 50-foot intervals 100 feet waterward of the shoreline. Four buoys will be installed at Day Use and Soda Bay Beaches, two at Mohi Beach.

The Lake County Board of Supervisors has authorized the installations, and has directed the Lake County Sheriff to enforce the "no boating" zones.

The consideration will be the public benefit.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO STATE DEPARTMENT OF PARKS AND RECREATION A FIFTEEN-YEAR PERMIT, IN CONSIDERATION OF THE PUBLIC BENEFIT, FOR THE PLACEMENT OF REGULATORY MARKER BUOYS AROUND PERIMETERS OF THE FOLLOWING-DESCRIBED PARCELS OF LAND:

THREE PARCELS OF SUBMERGED LAND 10 FEET WIDE IN CLEAR LAKE, LAKE COUNTY, ALL WITHIN SECTION 36, T. 14 N., R. 9 W., M.D.M., AND LYING 5 FEET ON EITHER SIDE OF THE FOLLOWING-DESCRIBED CENTERLINES:
