

8. MODIFICATION OF DREDGING PERMIT P.R.C. 3417.9, SAN FRANCISCO BAY AREA
RAPID TRANSIT DISTRICT - W.O. 5546.

After consideration of Supplemental Calendar Item 6 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A MODIFICATION OF PERMIT P.R.C. 3417.9 TO THE SAN FRANCISCO BAY AREA RAPID TRANSIT DISTRICT FOR THE DISPOSAL OF DREDGED MATERIAL IN AN AREA ONE MILE OFFSHORE FROM SAN FRANCISCO IN ACCORDANCE WITH THE CONDITIONS SPECIFIED BY THE DEPARTMENT OF FISH AND GAME AND THE SAN FRANCISCO BAY REGIONAL WATER POLLUTION CONTROL BOARD'S RESOLUTION NO. 775. THE ISSUANCE OF A PERMIT IS TO BE SUBJECT TO THE ISSUANCE OF A DEPARTMENT OF THE ARMY PERMIT BY THE CORPS OF ENGINEERS FOR THE CONDUCT OF THE PROPOSED OPERATION.

MODIFICATION OF DREDGING PERMIT P.R.C. 3417.9, SAN FRANCISCO BAY AREA RAPID TRANSIT DISTRICT - W.O. 5546.

On September 23, 1965 (Minute Item 5, page 11,700), the Commission authorized the Executive Officer to issue to the San Francisco Bay Area Rapid Transit District a permit to dredge 4,000,000 cubic yards of material to form a trench for the Trans-Bay Tube and to place the dredged material in public disposal areas in San Francisco Bay.

An application has been received from Trans-Bay Construction on behalf of the San Francisco Bay Area Rapid Transit District for a permit to dispose of the dredged material in an area one mile offshore from San Francisco (Exhibit "A"). This is in accordance with a request of the San Francisco Bay Conservation and Development Commission that the applicant dispose of the dredged material outside of the bay.

The Department of Fish and Game and the Division of Beaches and Parks were informed of the proposed operation and these agencies recommended the following:

1. The operator shall, in cooperation with the California Department of Fish and Game, conduct a bottom faunal survey and monitor the proposed dump site and adjacent area.
2. The operator shall comply with the San Francisco Bay Regional Water Pollution Control Board's Resolution No. 775.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A MODIFICATION OF PERMIT P.R.C. 3417.9 TO THE SAN FRANCISCO BAY AREA RAPID TRANSIT DISTRICT FOR THE DISPOSAL OF DREDGED MATERIAL IN AN AREA ONE MILE OFFSHORE FROM SAN FRANCISCO IN ACCORDANCE WITH THE CONDITIONS SPECIFIED BY THE DEPARTMENT OF FISH AND GAME AND THE SAN FRANCISCO BAY REGIONAL WATER POLLUTION CONTROL BOARD'S RESOLUTION NO. 775. THE ISSUANCE OF A PERMIT IS TO BE SUBJECT TO THE ISSUANCE OF A DEPARTMENT OF THE ARMY PERMIT BY THE CORPS OF ENGINEERS FOR THE CONDUCT OF THE PROPOSED OPERATION.
