APPLICATION FOR RECREATIONAL MINOR-STRUCTURE PERMIT TO ANCHOR TWO RUCYS AND A RAFT ON SUBMERGED LAND IN LAKE TAHOE, EL DORADO COUNTY; A. J. NELDAM - W.O. 6205.

Mr. A. G. Neldam, owner of the adjacent upland, has applied for a recreational minor-structure permit to anchor two small mooring buoys and a 9×9 -foot timber raft in Lake Tahoe at Sugar Pine Point (see Exhibit "A'), El Dorado County.

A U. S. Army Corps of Engineers navigational permit was issued, after having been processed through the Resources Agency.

This State permit will be additional to a rent-free recreational pier permit (P.R.C. 2287.9) which was issued to Mr. Neldam on December 1, 1958, for ten years. The buoys and raft will be located waterward of the pier.

A fee of \$25 for a 5-year permit has been paid.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO A. G. NELDAM, FOR A FEE OF \$25, A FIVE-YEAR RECREATIONAL MINOR-STRUCTURE PERMIT FOR THE PLACEMENT AND MAINTENANCE OF TWO SMALL MOORING BUOYS AND A RAFT ON THE FOLLOWING-DESCRIBED LAND:
