5. APPLICATION FOR DREDGING PERMIT - TIDE AND SUBMERGED LANDS, SAN DIEGO BAY, SAN DIEGO COUNTY; SAN DIEGO UNIFIED PORT DISTRICT - W.O. 6231, P.R.C. 3627.9.

After consideration of Calendar Item 38 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT TO THE SAN DIEGO UNIFIED PORT DISTRICT TO DREDGE APPROXIMATELY 640,000 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM AN AREA OF STATE-OWNED TIDE AND SUBMERGED LANDS IN THE BED OF SAN DIEGO BAY, SAN DIEGO COUNTY, DESCRIBED AS FOLLOWS:

EAST BASIN

BEGINNING AT A POINT WHICH LIES SOUTH  $82^{\circ} 33' 11''$  EAST A DISTANCE OF 500.00 FEET FROM HARBOR LINE STATION NO. 457-E-1 ON THE COMBINED U. S. PIERHEAD AND BULKHEAD LINE AS SAID LINES ARE NOW ESTABLISHED FOR THE BAY OF SAN DIEGO BY THE CORPS OF ENGINEERS; THENCE NORTH  $82^{\circ} 33' 11''$  WEST A DISTANCE OF 500.00 FEET TO HARBOR LINE STATION NO. 457-E-1; THENCE NORTH  $7^{\circ} 23' 49''$  EAST A DISTANCE OF 479.58 FEET TO HARBOR LINE STATION NO. 457-F-1, THENCE NORTH  $82^{\circ} 33' 11''$  WEST A DISTANCE OF 2360.43 FEET TO HARBOR LINE STATION NO. 457-G; THENCE NORTH  $25^{\circ} 09' 07''$  WEST A DISTANCE OF 326.95 FEET TO HARBOR LINE STATION NO. 457-I; THENCE NORTH  $46^{\circ} 12' 32''$  EAST A DISTANCE OF 214.84 FEET TO HARBOR LINE STATION NO. 465-A; THENCE SOUTH  $85^{\circ} 23' 00''$  EAST A DISTANCE OF 3052.26 FEET TO HARBOR LINE STATION NO. 467; THENCE SOUTHWESTERLY TO THE POINT OF BEGINNING.

APPLICATION FOR DREDGING PERMIT - TIDE AND SUBMERGED LANDS, SAN DIEGO BAY, SAN DIEGO COUNTY; SAN DIEGO UNIFIED PORT DISTRICT - W.O. 6231.

An application has been received from the San Diego Unified Port District for a permit to dredge approximately 640,000 cubic yards of material from the east and west basins of Harbor Island in North San Diego Bay. The dredging of these basins, according to Port officials, is necessary to facilitate construction of needed marinas and other small boat anchorages. The dredged material will be deposited in two different areas under jurisdiction of the Port District; one area is located on Harbor Island adjacent to the dredge area, the other on nearby Lindberg Field. The dredge and disposal areas are within an area granted to the City of San Diego (Chap. 700, Stats. 1911).

Section 6303 of the Public Resources Code provides that when an applicant has a permit from the federal government, the Commission may grant the privilege of removing or extracting material from tide or submerged lands owned by the State for the improvement of navigation, upon such terms and conditions and for such consideration as will be for the best interests of the State.

The U. S. Corps of Engineers has issued a Department of the Army permit authorizing the conduct of dredging at the location described in the application. The Division of Beaches and Parks has reported that while the application has no direct effect on any current project or program of theirs, it urges that the permit conditions consider and protect the recreation and scenic quality of any water body or shoreline in the area by regulating construction activities which would adversely affect these qualities.

The Department of Fish and Game has stated that it does not object to the contemplated dredging inasmuch as the dredged material will be used for fill on Lindberg Field and Harbor Island, and therefore does not feel that any damage to marine resources could result from the operation.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO THE SAN DIEGO UNIFIED PORT DISTRICT TO DREDGE APPROXIMATELY 640,000 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM AN AREA OF STATE-OWNED TIDE AND SUBMERGED LANDS IN THE BED OF SAN DIEGO BAY, SAN DIEGO COUNTY, DESCRIBED AS FOLLOWS:
