APPLICATION FOR BRIDGE EASEMENT OVER TIDE AND SUBMERGED LANDS IN CACHE SLOUGH, SOLANO COUNTY; COUNTY OF SOLANO - W.O. 4947.

The County of Solano has requested issuance of a 49-year right-of-way easement for the construction of a bridge across 1.35 acres of sovereign land in Cache Slough, connecting with Liberty Island, and approximately 200 feet above its junction with Prospect Slough (as shown on Exhibit "A").

The bridge, which replaces a ferry operating nearby, will have a movable bascule-type steel span providing a horizontal clearance of 80 feet and a vertical clearance in the closed position of 21 feet above mean lower low water and 8 feet above high water. The fixed portion of the bridge will consist of timber and concrete, with concrete pipe bents. The roadway width will be 26 feet, and the entire length of the bridge will be 572.9 feet.

A U. S. Army Corps of Engineers navigational permit has been issued.

The consideration will be the public use and benefit.
