A PARCEL OF SUBMERGED LAND 30 FEET WIDE IN LAKE TAMOE, PLACER COURTY, APPROXIMATELY 0.1 MILE NORTHWESTERLY FROM THE PLACER AND EL DORADO COUNTY LINE, LYING 15 FEET ON EITHER SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

BEGINNING AT A POINT ON THE LOW WATER MARK OF LAKE TAHOE WHICH BEARS N. 60° 52' 33" W., 55 FEET MORE OR LESS FROM STATION NO. 8 AS SHOWN UPON SHEET 2 OF 22 OF THAT CERTAIN MAP ENTITLED "SURVEY OF THE LOW WATER MARK ON THE SHORE OF LAKE TAHOE", SEPTEMBER 1950, PREPARED BY THE STATE LANDS DIVISION AND RECORDED IN BOOK 2 OF SURVEYS AT PAGE 81, PLACER COUNTY RECORDER'S OFFICE, THENCE N. 39° 66' E., 30 FEET, CONTAINING 0.021 ACRE MORE OR LESS.
