APPLICATION TO LEASE 29 PARCELS OF TIDE AND SUBMERGED LANDS AT SANTA CATALINA ISLAND, LOS ANGELES COUNTY; SANTA CATALINA ISLAND COMPANY - W.O. 5239.

Lease P.R.C. 185.1, covering 17 noncontiguous parcels of tide and submerged lands at Santa Catalina Island, was issued to the Santa Catalina Island Company on August 29, 1950, for a period of 15 years with a tenyear renewal option. The lease was issued to cover installation of mooring buoys in various coves to provide anchorage for small craft. The annual rental was \$1,643.40, which the lessee has been paying as a tenant in sufferance since the lease expiration.

In lieu of exercising the ten-year renewal option, the applicant requested a 15-year lease of 29 parcels. The new lease has no renewal options.

Based upon an appraisal of all parcels, the annual rental under a new lease has been computed to be \$19,217.86. The lease will also provide for a \$10,000.00 surety bond.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A 15-YEAR LEASE TO THE SANTA CATALINA ISLAND COMPANY OF 29 PARCELS OF TIDE AND SUBMERGED LANDS AT AN ANNUAL RENTAL OF \$19,217.86, THE LEASE TO PROVIDE FOR A \$10,000.00 SURFEY BOND.

Parcel 1 - Pebbly Beach Wharf Site: An area 100 feet in width lying 50 feet on each side of the center line of an existing wharf, the shoreward end of said center line being at approximately 33° 20' North Latitude, 118° 18' 29" West Longitude, and extending 200 feet seaward from the mean high tide line.

Parcel 15 - Emerald Bay: All that area bounded on the west and south by the mean high tide line and on the north by a straight line extending from a point on the mean high tide line at approximately 33° 27' 58" North Latitude, 118° 31' 20" West Longitude to a point on the mean high tide line at approximately 33° 28' 10" North Latitude, 118° 31 45" West Longitude.

Containing an area of 34.8 acres, more or less.

Parcel 16 - Catalina Harbor: All that area bounded on the west, north and each by the mean high tide line and on the south by a straight line which extends from a point on the mean high tide line at approximately 33° 25' 41" North Latitude, 118° 30' 21" West Longitude, to a point on the mean high tide line at approximately 33° 25' 41" North Latitude, 118° 30' 39" West Longitude, except that portion of tide-land owned by the Santa Catalina Island Company generally described as a portion of Tideland in Catalina Harbor of approximately 12.8 acres lying between the ordinary high water and ordinary low water mark along the east and north shore of Catalina Harbor beginning at Ballast Point.

Containing an area of 1.8 acres, more or less.

<u>Parcel 22 - Ripper's Cove</u>: All that area bounded on the east, south and west by the mean high tide line and a straight line on the north, beginning at a point on the mean high tide line at approximately 33° 25' 40" North Latitude, 118° 26'03" West Longitude and extending to a point on the mean high tide line at approximately 33° 25' 38" North Latitude, 118° 25' 50" West Longitude.

Parcel 24 - Parson's Landing: All that area bounded on the east, south and west by the mean high tide line and on the north by a straight line extending from a point on the mean high tide line at approximately 33° 28' 26" North Latitude, 118° 33' 09" West Longitude, to a point on the mean high tide line at approximately 33° 28' 08" North Latitude, 118° 32' 55" West Longitude.

Containing an area of 3.5 acres, more or less.
