36. MODIFICATION OF THE 1966 PLAN OF DEVELOPMENT AND OPERATIONS TO CHANGE THE BOTTOM HOLE LOCATION OF WELL J-115, LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY - W.O. 5200.301 AND W.O. 5200.317.

After consideration of Calendar Item 11 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION APPROVES THE ACTION BY THE EXECUTIVE OFFICER, PURSUANT TO SECTION 5(g), CHAPTER 138, STATUTES OF 1964, 1ST E.S., CONSENTING TO A MODIFICATION OF THE 1966 PLAN OF DEVELOPMENT AND OPERATIONS, LONG BEACH UNIT, CHANGING THE BOTTOM-HOLE LOCATION OF WELL J-115 TO THE REVISED COORDINATES, AS SET FORTH IN THE LONG BEACH CITY MANAGER'S LETTER, DATED SEPTEMBER 22, 1966.

MODIFICATION OF THE 1966 PLAN OF DEVELOPMENT AND OPERATIONS TO CHANGE THE BOTTOM HOLE LOCATION OF WELL J-115, LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY - W.O. 5200.301 AND W.O. 5200.317.

The City of Long Beach and the State, pursuant to the provisions of Section 5(g), Chapter 138, Statutes of 1964, 1st E.S., have mutually agreed to a modification of the 1966 Plan of Development and Operations, Long Beach Unit, to change the bottom-hole location of Well J-115 to a location approximately 145 feet southwest of the present approved location.

The bottom-hole location of Well J-115 was approved, as a part of the Third Quarter Drilling Schedule, by the Commission at its meeting of July 12, 1966. Actual drilling of Well J-115 revealed wet and silty sand at the approved bottom-hole location. After review by City and State Lands Division engineers, it was decided to plug back Well J-115 to a new bottom-hole location. The coordinates of the original approved bottom-hole location and the revised bottom-hole location are as follows:

The Executive Officer, by letter dated October 3, 1966, consented to a modification of the 1966 Plan of Development and Operations, changing the bottom-hole location of Well J-115 to the revised coordinates, as set forth in the Long Beach City Manager's letter, dated September 22, 1966.
