APPLICATION FOR APPROVAL OF SUBMARINE TELEPHONE CABLES ON STATE LAND IN CLEAR LAKE, LAKE COUNTY; THE FACIFIC TELEPHONE AND TELEGRAPH COMPANY - W.O. 6327.

The Pacific Telephone and Telegraph Company has requested approval of the location of submarine telephone cables, together with necessary appurtenances thereto, along the easterly shore of Clear Lake in Lake County. The lines will commence about 2.0 miles south of Lucerne and run 1.76 miles southerly. (See Exhibit "A" for location.)

The Commission previously adopted an "Approval-of-Location Agreement Form", in accordance with Section 7501 of the Public Utilities Code and with Attorney General's Opinion No. 52/56.
