APPLICATION FOR REPLACEMENT, RIGHT-OF-WAY EASEMENT, SUBMARINE CABLE CROSSING MALLARD SLOUGH, CONTRA COSTA COUNTY; STATE DEPARTMENT OF WATER RESOURCES - W.O. 6306.

The Department of Water Resources has requested a 49-year replacement right-of-way easement covering an existing cable across Mallard Slough. The easement, which was covered by expired Lease P.R.C. 3072.9, is 5 feet wide, 167 feet long, contains 0.019 acre, and is located 1.5 miles northwest of Pittsburg, Contra Costa County (see Exhibit "A").

The cable serves two existing current meters in Suisun Bay, plus recording equipment on Mallard Island.

The consideration will be the public welfare.
