On December 6, 1965, an application was received from L. J. Fee of Fort Bidwell, California, to purchase the  $SE^{1}_{4}$  of  $SE^{1}_{4}$  of Section 16, T. 46 N., R. 17 E., M.D.M., containing 40 acres in Modoc County.

A staff appraisal indicates that the land is not suitable for cultivation without artificial irrigation, and establishes the value of \$30 per acre, or a total value of \$1,200.

## THE PROPERTY

Location: 7 airline miles east of Fort Bidwell and one mile

west of the Nevada state line.

Access: Three miles of surface road, three miles of gravel

road, and one mile of dirt road.

Water: No surface water; subsurface water is unknown.

Terrain: Level to low rolling hills, gentle to moderate

slove.

Elevation: 5,240 to 5,280 feet.

Cover: Low sagebrush, scattered juniper, scattered bunch

grass, and other low-growing plants.

Highest and Best Use: Reservoir site.

The applicant amended his offer in writing, concurring with the appraised value of \$1,200.

The land was advertised for sale with the stipulation that any new bids must be in excess of the appraised value of \$1,200. As a result of advertising, the applicant, L. J. Fee, submitted the minimum cash required to qualify his previous written offer of \$1,200, and increased his bid to \$37.50 per acre, for a total of \$1,500. No further bids were received pursuant to advertis. 3.
