APPLICATION FOR TEMPORARY RIGHT-OF-ENTRY PERMIT, STATE SCHOOL LAND, SECTION 2, T. 5 S., R. 15 E., M.D.M., MARIPOSA COUNTY; MERCED IRRIGATION DISTRICT - W.O. 6350.

The Merced Irrigation District has requested a temporary right-of-entry permit covering 22.1 acres of State school land located in Section 2, T. 5 S., R. 15 E., M.D.M., about 6 miles south of Merced Falls in Mariposa County (see Exhibit "A" for location).

The District applied to purchase the subject land on October 10, 1966; about six months will be required to process the sale. The land will be used for reservoir and recreational purposes. In order to complete the project in 1967, it is necessary to proceed immediately with sewage-treatment facilities, tree planting, and construction of roads. A right-of-entry permit for a period of six months will facilitate the necessary advance work pending completion of the sale.

The consideration for the permit will be the public use and benefit.
