

4. APPLICATION FOR EXTENSION OF DREDGING PERMIT, TIDE AND SUBMERGED LANDS, SUISUN SLOUGH, SOLANO COUNTY; FAIRFIELD-SUISUN SEWER DISTRICT - W.O. 6414, P.R.C. 3404.9.

After consideration of Calendar Item 35 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXTEND THROUGH JULY 1, 1968, THE PERIOD OF DREDGING PERMIT P.R.C. 3404.9, WHICH COVERS PORTIONS OF SUISUN SLOUGH DESCRIBED AS FOLLOWS:

ALL THAT CERTAIN REAL PROPERTY SITUATE, LYING AND BEING IN SOLANO COUNTY, CALIFORNIA, BEING A PORTION OF SWAMP & OVERFLOW SURVEY NUMBER 103, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

APPLICATION FOR EXTENSION OF DREDGING PERMIT, TIDE AND SUBMERGED LANDS, SUISUN SLOUGH, SOLANO COUNTY; FAIRFIELD-SUISUN SEWER DISTRICT - W.O. 6414, P.R.C. 3404.9

On November 18, 1965, the State Lands Commission authorized the Fairfield-Suisun Sewer District to dredge approximately 9,000 cubic yards of material, without payment of royalty, from an area of state-owned tide and submerged lands in portions of Suisun Slough which surround Pierce's Island opposite Suisun City, Solano County. The spoils dredged from the channel were to be used to construct exterior levees for an oxidation ponding system on the island, which is owned in fee by the aforesaid District, a public body encompassing the areas of the cities of Fairfield and Suisun City which was formed by an act of the State Legislature.

An application has been submitted by the District stating that the proposed work has not been completed, and requesting that the authorized dredging permit be extended.

The contract for the work runs to March 31, 1968; the U. S. Corps of Engineers has issued a Department of the Army permit, through December 31, 1968, authorizing the conduct of dredging operations at the location described in the application. The Bay Area Conservation and Development Commission has issued a permit through July 1, 1968.
