16. APPLICATION FOR EXTENSION OF TERM OF DREDGING PERMIT, TIDE AND SUBMERGED LANDS, SUNSET HARBOUR, ORANGE COUNTY; DECON CORPORATION - W.O. 6399, P.R.C. 3355.1.

APPLICATION FOR EXTENSION OF TERM OF DREDGING PERMIT, TIDE AND SUBMERGED LANDS, SUNSET HARBOUR, ORANGE COUNTY; DECON CORPORATION - W.O. 6399, P.R.C. 3355.1.

On August 26, 1965 (Minute Item 17, page 11,599), the State Lands Commission authorized the Executive Officer to issue to Decon Corporation, a dredging permit (P.R.C. 3355.1) authorizing the dredging of approximately 40,000 cubic yards of material, at a royalty rate of \$0.05 per cubic yard for all material extracted, from an area of tide and submerged lands in the bed of the Sunset Harbour main channel, Orange County.

Subject permit expires on December 31, 1966, and the permittee has requested an extension of the term of the permit through March 31, 1967. Permittee has removed a portion of the yardage (9,556 cubic yards) but has stated that it will be impossible to remove the balance by expiration date.

The U.S. Army Corps of Engineers permit, which authorizes the proposed dredging, has no time limit.
