APPLICATION FOR PERMIT TO CONSTRUCT FISH HATCHERY ON SOVEREIGN LAND OF FEATHER RIVER AT OROVILLE, BUTTE COUNTY; STATE DEPARTMENT OF WATER RESOURCES - W.O. 6202.

The Department of Water Resources has requested a permit to occupy three parcels of sovereign land in Feather River at Orc ille (see Exhibit "A" for location) for construction, operation, and maintenance of the State facility known as the Feather River Fish Hatchery. The adjoining uplands are owned by the State and under jurisdiction of the Department of Water Resources.

The hatchery is scheduled for completion in the fall of 1967, and will cost approximately \$3,000,000. Upon completion, the Department of Water Resources will transfer operational responsibility to the Department of Fish and Game, but will retain financial jurisdiction and control over the facility and underlying land.

The U. S. Army Corps of Engineers does not exercise navigational jurisdiction in the area.

The consideration for issuance of a 49-year permit will be the Statewide public interest and benefit.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE DEPARTMENT OF WATER RESOURCES, IN CONSIDERATION OF THE PUBLIC INTEREST AND BENEFIT, A 49-YEAR PERMIT FOR THE CONSTRUCTION, MAINTENANCE, AND OPERATION OF A FISH HATCHERY ON LAND IN BUTTE COUNTY DESCRIPED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
