

18. APPLICATION FOR EXTENSION OF TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2828.1; SANTA BARBARA, VENTURA, LOS ANGELES, AND ORANGE COUNTIES; STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OPERATIONS, INC.

After consideration of Calendar Item 33 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OPERATIONS, INC., AN EXTENSION OF THE TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2828.1 FOR THE PERIOD FEBRUARY 16, 1967, THROUGH AUGUST 15, 1967, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT ARGUELLO, SANTA BARBARA COUNTY, AND THE SEAWARD EXTENSION OF A LINE FORMING THE NORTHWESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY. ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.

An application has been received from Standard Oil Company of California, Western Operations, Inc., for an extension of the term of Geological Survey Permit P.R.C. 2828.1 for the period February 16, 1967, through August 15, 1967, in order to continue core-drilling operations. The present permit will expire on February 15, 1967.
