5. APPLICATION FOR RECREATIONAL MINOR-STRUCTURE PERMIT, SUBMERGED LAND IN LAKE TAHOE, PLACER COUNTY; A. C. BURDETTE - W.O. 6374, P.R.C. 3721.1.

After consideration of Calendar Item 9 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO A. C. BURDETTE, FOR A FEE OF \$25, A 5-YEAR RECREATIONAL MINOR-STRUCTURE PERMIT TO ANCHOR A BUOY ON THE FOLLOWING-DESCRIBED LAND:

A CIRCULAR PARCEL OF SUBMERGED LAND 10 FEET IN DIAMETER IN THE BED OF LAKE TAHOE, PLACER COUNTY, LYING 125 FEET WATERWARD OF THE PIER WHICH IS COVERED BY STATE LEASE P.R.C. 3270.1; THE CENTERPOINT OF SAID CIRCULAR PARCEL HAS APPROXIMATE CALIFORNIA ZONE 2 COORDINATE VALUES OF X = 2,542,320 Y = 569,860, AND CONTAINS 0.002 ACRE MORE OR LESS.

APPLICATION FOR RECREATIONAL MINOR-STRUCTURE PERMIT, SUBMERGED LAND IN LAKE TAHOE, PLACER COUNTY; A. C. BURDETTE - W.O. 6374.

Mr. A. C. Burdette of Davis has requested a permit to anchor a 12-inch mooring buoy in 16 feet of water in Lake Tahoe near Watson Creek, Placer County (as shown on Exhibit "A").

The buoy will be bottomed on State submerged land fronting upland owned by the Ridgewood Property Owners Association and 125 feet waterward of their existing pier. The Association has, by vote of its Board of Directors, stated that it does not object to placement of the buoy as requested.

A U. S. Army Corps of Engineers navigational permit has been issued and the County of Placer has registered no objection.

A permit will be issued for five years at a total fee, pursuant to current commission policy, of \$25.
