APPLICATION FOR A PERMIT TO CONDUCT SUBMARINE GEOPHYSICAL EXPLORATION OPERATIONS ON TIDE AND SUBMERGED LANDS OF THE STATE OF CALIFORNIA; MENDOCINO, SONOMA, MARIN, SAN FRANCISCO, SAN MATEO, SANTA CRUZ, MONTEREY, SAN LUIS OBISPO, SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE, AND SAN DIEGO COUNTIES; UNION OIL COMPANY OF CALIFORNIA - W.O. 6526, P.R.C. 3741.1.

After consideration of Calendar Item 10 attached, and upon motion duly made and carriad, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO UNION OIL COMPANY OF CALIFORNIA A GEOPHYSICAL EXPLORATION PERMIT, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOPHYSICAL EXPLORATION OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION, IN THE AREA LYING BETWEEN THE SEAVARD EXTENSION OF NORTHERN BOUNDARY OF MENDOCINO COUNTY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA EXCEPT THE FOLLOWING:

- 1. SAN FRANCISCO BAY AND OTHER INLAND WATERS DRAINING THEREIN;
- 2. LANDS INCLUDED IN SECTION 6871.2(b) OF THE PUBLIC RESOURCES CODE;
- 3. LANDS LYING ADJACENT TO THE MAINLAND BETWEEN A LINE FORMING THE NORTHWESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY, AND THE SEAWARD EXTENSION THEREOF, AND A LINE FORMING THE SOUTH-EASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ALL OF ITS INSPECTION COSTS. THE PERMIT IS TO BE EFFECTIVE ONLY AS LONG AS A CONCURRENT PERMIT BY THE FISH AND GAME COMMISSION IS IN EFFECT FOR THE SAME OPERATING AREA.

An application has been received from Union Oil Company of California for a permit to conduct geophysical exploration operations in the area lying between the northern boundary of Mendocino County and the seaward extension thereof, and the southern boundary of the State of California.

The Boards of Supervisors of the counties of Mendocino, Sonoma, Marin, San Francisco, San Mateo, Santa Cruz, Monterey, San Luis Obispo, Santa Barbara, Ventura, Lor Angeles, Orange, and San Diego; the Mayor and the City Council of the City of Santa Barbara; and the Greater Santa Cruz Chember of Commerce have been informed that this application is to be considered.

The statutory filing fee has been paid by the applicant.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO UNION OIL COMPANY OF CALIFORNIA A GEOPHYSICAL EXPLORATION PERMIT, CONFORMING TO ALL CPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOPHYSICAL EXPLORATION OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION, IN THE AREA LYING BETWEEN THE SEAWARD EXTENSION OF NORTHERN BOUNDARY OF MENDOCINO COUNTY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA EXCEPT THE FOLLOWING:

- 1. SAN FRANCISCO BAY AND CTHER INLAND WATERS DRAINING THEREIN;
- 2. LANDS INCLUDED IN SECTION 6871.2(b) OF THE PUBLIC RESOURCES CODE;
- 3. LANDS LYING ADJACENT TO THE MAINLAND BETWEEN A LINE FORMING THE NORTH-WESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY, AND THE SEAWARD EXTENSION THEREOF, AND A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF.

THE PERMITTYE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ALL OF ITS INSPECTION COSTS. THE PERMIT IS TO BE EFFECTIVE ONLY AS LONG AS A CONCURRENT PERMIT BY THE FISH AND GAME COMMISSION IS IN EFFECT FOR THE SAME OPERATING AREA.
