18. APPLICATION FOR EXTENSION OF TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2790.1, SANTA BARBARA, VENTURA, LOS ANGELES, AND ORANGE COUNTIES; PAULEY PETROLEUM INC.

After consideration of Calendar Item 5 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO PAULEY PETROLEUM INC. AN EXTENSION OF THE TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2790.1 FOR THE PERIOD APRIL 14, 1967, THROUGH OCTOBER 13, 1967, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT ARGUELLO, SANTA BARBARA COUNTY, AND THE EXTENSION SEAWARD OF THE NORTHERLY LIMITS OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY. ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.

An application has been received from Pauley Petroleum Inc., for an extension of the term of Geological Survey Permit P.R.C. 2790.1 for the period April 14, 1967, through October 13, 1967, in order to continue core-drilling operations. The present permit will expire on April 13, 1967.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO PAULEY PETROLEUM INC.
