2. PROFOSED OIL AND GAS LEASE, TIDE AND SUBMERGED LANDS, SOLANO AND CONTRA COSTA COUNTIES - W.O. 6220 (PARCEL 47), P.R.C. 3742.1.

After consideration of Calendar Item 2 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION ACCEPTS THE BID MADE BY STANDARD OIL COMPANY OF CALIFORNIA ON MARCH 23, 1967, AND AUTHORIZES THE EXECUTIVE OFFICER TO ISSUE AN OIL AND GAS LEASE TO THE AFORESAID BIDDER FOR APPROXIMATELY 3,489 ACRES OF TIDE AND SUBMERGED LANDS DESIGNATED AS W.O. 6220 (PARCEL 47), IN SUISUN BAY, SOLANO AND CONTRA COSTA COUNTIES, AS DETAILED IN THE NOTICE OF INTENTION PUBLISHED JANUARY 25, 1967, AND FEBRUARY 1, 1967. On March 23, 1967, three bids were received in response to a published Notice of Intention of the State Lands Commission to enter into a lesse for the extraction of oil and gas from approximately 3,469 acres of tide and submerged lands designated as W.O. 6220 (Percel 47) in Suisun Ray, Solano and Contra Counties. This offer was authorized by the Commission on Jeruary 24, 1967 (Minute Item 28, page 55).

The bids submitted were reviewed by the staff as to technical sufficiency and economic factors. The Office of the Attorney General has reviewed the highest bid, submitted by Standard Oil Company of California and has determined:

- A. That the Commission has complied with the procedural requirements of law;
- B. That the bid submitted conforms with:
 - 1. The bid requirements as specified in the proposals of the Commission;
 - 2. The applicable provisions of law; and
 - 3. The rules and regulations of the Commission.

A summary tabulation of the bonus-payment offers received pursuant to the lease proposal is attached as Exhibit "A".
