After consideration of Calendar Item 11 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A 5-YEAR PERMIT, IN CONSIDERA-TION OF THE PUBLIC SAFETY, TO THE COUNTY OF SAN JOAQUIN, FOR THE PLACEMENT AND PROPER MAINTENANCE OF TWO SPEED-REGULATION BUOYS ON THE FOLLOWING-DESCRIBED SOVEREIGN LAND:

TWO CIRCULAR PARCELS OF SUBMERGED LAND 20 FEET IN DIAMETER SIZUATE WESTERLY OF LATHROP AND LYING ABOUT 400 FEET APART IN THE BED OF THE SAN JOAQUIN RIVER, SAN JOAQUIN COUNTY, CALIFORNIA; THE CENTERPOINTS OF SAID PARCELS HAVE APPROXI-MATE CALIFORNIA ZONE 3 COORDINATE VALUES OF:

APPLICATION FOR PERMIT TO PLACE BUOYS ON STATE LAND IN SAN JOAQUIN RIVER, SAN JOAQUIN COUNTY; COUNTY OF SAN JOAQUIN - W.O. 6357.

The County of San Joaquin has requested a 5-year permit to anchor two buoys at Mile 49.9 in the San Joaquin River near Lathrop (as shown on Exhibit "A").

It is intended that the buoys shall regulate speed of watercraft passing a boat-launching ramp located at a public park facility. The buoys, of plastic material, 19^{111}_{5} diampter and 5' in height, will be anchored 200' northerly and southerly of the ramp at distances of 75' west of the waterline.

A U. S. Army Corps of Engineers navigational permit has been issued.

The consideration will be the public safety.

IT IS RECOMMENDED THAT THE COMMISSION ANTHORIZE THE EXECUTIVE OFFICER TO ISSUE A 5-YEAR PERMIT, IN CONSIDERATION OF THE PUBLIC SAFETY, TO THE COUNTY OF SAN JOAQUIN, FOR THE PLACEMENT AND PROPER MAINTENANCE OF TWO SPEED-REGU-LATION BUOYS ON THE FOLLOWING-DESCRIBED SOVEREIGN LAND:
