APPLICATION FOR COMMERCIAL MINOR-STRUCTURE PERMIT TO MAINTAIN THREE MOORING BUOYS IN SANTA MONICA BAY AT PARADISE COVE, LOS ANGELES COUNTY; GORDON HOMES, INC., D.B.A. PARADISE COVE SPORTFISHING - W.O. 6386.

Gordon Homes, Inc., d.b.a. Paradise Cove Sportfishing, of Malibu, requests a permit to maintain three mooring buoys on submerged land in Santa Monica Bay at Paradise Cove near Malibu in Los Angeles County (as shown on Exhibit "A").

The buoys, which are located seaward of a fishing pier site covered by Lease P.R.C. 391.1, have been authorized by the U. S. Army Corps of Engineers.

A fee of \$100 for each site (total \$300) will be charged for a five-year permit.
