APPLICATION FOR EXTENSION OF TERM OF AMFIDED GEOLOGICAL SURVEY PERMIT P.R.C. 2791.1; SANTA BARBARA, VENTURA, LOS ANGELES, AND ORANGE COUNTIES; ATLANTIC RICHFIELD COMPANY.

An application has been received from Atlantic Richfield Company for an extension of the term of amended Geological Survey Permit P.R.C. 2791.1 for the period May 16, 1967, through November 15, 1967, in order to continue core-drilling operations. The present permit will expire on May 15, 1967.
